Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Mater Lakes 5 Acre Site Campus bounded on the north approximately 430 feet south of NW 174 Terrace, on the east approximately 660 feet west of NW 87 Avenue, on the south by NW 170 Street, and on the west by NW 88 Place.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 13, which is represented by Senator Rene Garcia.

There are no delegation requirements with this item.



LOCATED IN THE SOUTHEAST 1/4 OF SECTION 9, **TOWNSHIP** SOUTH, 52 **RANGE** 40 (BOUNDED ON THE NORTH APPROXIMATELY 430 FEET SOUTH OF NW 174 TERRACE, ON THE EAST APPROXIMATELY 660 FEET WEST OF NW 87 AVENUE, ON THE SOUTH BY NW 170 STREET, AND ON THE WEST BY NW 88 PLACE)
