The proposed ordinance creates section 5-26 of Chapter 5 of the Code of Miami-Dade County by creating an Animal Services Advisory Board and provides purpose, composition and duties of the board and other related matters.

- The Animal Services Advisory Board is expected to advise on best practices to address animal welfare needs including the overpopulation of abandoned or surrendered animals to the Miami-Dade County Animal Services Pet Adoption and Protection Center.
- The Animal Services Advisory Board will advise on providing animal welfare services in areas of the County that have fewer resources available.
- The Animal Services Advisory Board will be comprised of 19 members with animal welfare expertise with members appointed directly by the Board of County Commissioners, directly by the Mayor, and through nominations from organizations identified in the ordinance subsequently forwarded to the Board by the Mayor.
- The Department of Animal Services will assign a staff member to liaison with the board members and schedule meetings as needed.
- The Advisory Board will not have bonding authority nor will it have the authority to enter into contracts and spend county funds.

ORDINANCE RELATING TO ANIMALS; CREATING AN ANIMAL SERVICES ADVISORY BOARD; CREATING SECTION 5-26 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA; PROVIDING FOR PURPOSE, COMPOSITION AND DUTIES OF THE BOARD AND OTHER RELATED MATTERS; PROVIDING SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE

WHEREAS, in the Fiscal Year 2023-24 Budget, this Board is considering approving substantial additional funding to provide improved animal services for the purpose of reducing the number of dogs and cats that are abandoned or surrendered to the Miami-Dade Animal Services Pet Adoption and Protection Center, including through funding free and low-cost spay/neuter programs and facilities throughout the County, low-cost veterinary care programs, and responsible pet ownership educational programs; and

WHEREAS, to assure County taxpayers that their money is being used for appropriate purposes, this Board wishes to create an Animal Services Advisory Board ("ASAB") of residents and experts to make recommendations to the Board of County Commissioners and the County Mayor as to the expenditure of such additional funding for spay/neuter services and as to certain other matters related to caring for and reducing the number of dogs and cats that are abandoned or surrendered to the Miami-Dade Animal Services Pet Adoption and Protection Center,

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA:

Section 1. Section 5-26 of the Code of Miami-Dade County, Florida, is hereby created to read as follows:

Sec. 5-26. Animal Services Advisory Board ("ASAB").

- (a) *Creation, purpose, membership, and qualifications.* The Animal Services Advisory Board ("ASAB") is hereby created for the purpose of advising the Board of County Commissioners and the County Mayor as to certain matters relating to dogs and cats in the County's care.
 - (1) *Composition.* The ASAB shall be composed of 19 voting members, as follows:
 - (i) Each County Commissioner shall appoint one member.
 - (ii) The County Mayor shall appoint one member.
 - (iii) Each of the following organizations shall nominate a representative, to be appointed as provided in paragraph (2):
 - a. Humane Society of Greater Miami ("Humane Society").
 - b. The Pets' Trust Miami, Inc. ("Pets' Trust").
 - c. The South Florida Society for the Prevention of Cruelty to Animals ("SFSPCA").
 - d. The Cat Network, Inc. ("Cat Network").
 - e. The South Florida Veterinary Medical Association ("SFVMA").

(2) *Appointment procedure.*

- Each County Commissioner's and the County Mayor's appointments shall be effective upon the filing of written notice of said appointment with the Miami-Dade County Clerk of the Board. It is provided, however, that an appointment shall not be effective if an appointee does not meet all required qualifications in this section, in article IB of chapter 2, and as otherwise provided in this code.
- (ii) The following procedures shall govern appointment of representatives of organizations designated in subparagraph (1)(iii):
 - a. Each organization shall submit a written recommendation of at least one nominee who meets all required

qualifications in this section, in article IB of chapter 2, and as otherwise provided in this code to represent such organization, including the nominee's resume and the minutes of the meeting approving the nominee, to the County Mayor, who shall forward such nominees to the Board of County Commissioners in a timely manner.

- b. The Board of County Commissioners may then, in its discretion, appoint one of the respective organization's nominees to the ASAB via resolution.
- c. Where a designated organization fails to propose a nominee within 45 days of notification of a vacancy, the ASAB may recommend a nominee at an ASAB meeting and forward the minutes approving such nominee, together with the nominee's resume, to the County Mayor, who shall forward the nominee to the Board of County Commissioners in a timely manner. The Board of County Commissioners may then appoint such nominee via resolution.
- (3) Attendance, removal, and vacancies. Attendance, removals, and vacancies shall be governed by article IB of chapter 2, except that the appointing entities under subparagraphs (1)(b) and (c) may replace a prior appointee with a new appointee who meets all the above-mentioned qualifications upon the filing of written notice with the Miami-Dade Clerk of the Board. However, such entities are encouraged to maintain consistency to the extent feasible.
- $(4) \qquad Terms.$
 - (i) The initial term of each member appointed by the Commissioners of Districts 1, 3, 5, 7, 9, 11, and 13 and of each member representing the Humane Society, the SFSPCA, and the SFVMA shall be 4 years.
 - (ii) The initial term of each member appointed by the Commissioners of Districts 2, 4, 6, 8, 10, and 12 and each member representing the

Pets' Trust and the Cat Network shall be 3 years.

- (iii) Thereafter, each member shall be appointed for a term of four years.
- (iv) Terms expire in accordance with article IB of chapter 2.
- (5) *Qualifications*. Each member of the ASAB shall have experience and familiarity with issues related to the care of dogs and cats, animal shelter operations, or animal rescue programs and shall have an outstanding reputation of integrity, responsibility, and commitment to serving the community.
- (6) *Compensation*. ASAB members shall serve without compensation.
- (b) Organization, meetings, and public records.

(1)

- Bylaws, Rules, and Regulations.
 - (i) The ASAB shall be governed by article IB of chapter 2 and may establish, adopt, and amend bylaws, rules, and regulations for its own governance as are not inconsistent therewith.
 - (ii) If the ASAB does not adopt such rules or policies, or its adopted rules or policies do not address a particular situation, then the applicable provisions of the Board of County Commissioners' Rules of Procedure, as such may be amended from time to time, shall apply.
- (2) *Officers*. The ASAB shall elect a chairperson and a vice-chairperson from among its members, who shall serve at the will of the ASAB for one-year terms.
 - (i) The chairperson shall preside at all meetings at which he or she is present.
 - (ii) The vice-chairperson shall act as chairperson in the absence of the chairperson.
- (3) *Staff Support.* The ASAB shall have assistance from such staff as may be designated by the County Mayor or the County Mayor's designee. The staff shall:
 - (i) maintain and keep the records of the ASAB;
 - (ii) prepare, in cooperation with the chairperson, the agenda for each meeting;

- (iii) be responsible for the preparation of such reports, minutes, documents, resolutions, or correspondences as the ASAB may direct;
- (iv) generally administer the business and affairs of the ASAB, subject to budgetary limitations.
- (4) *Quorum*. A quorum shall be required to transact any business or exercise any power vested in the ASAB and shall be as provided in section 2-11.39.1.
- (c) *Meetings*. The ASAB shall hold meetings as it deems necessary, to the extent feasible and practicable, as determined by the County Mayor or County Mayor's designee. A special meeting may be called by the chairperson or by a written request of the majority of those persons duly appointed to the board.
- (d) *Powers and duties.* The ASAB shall have the following powers, duties, functions, and responsibilities:
 - (1) Make recommendations to the Board of County Commissioners ("Board") and the County Mayor ("Mayor") regarding expenditure of funds budgeted and allocated in the then-current fiscal year for spay/neuter programs and facilities throughout the County, low-cost veterinary care programs, responsible pet ownership educational programs, and other improved animal services for the purpose of reducing the number of, and providing appropriate care for, dogs and cats that are abandoned or surrendered to the Miami-Dade Animal Services Pet Adoption and Protection Center;
 - (2) Make recommendations to the Board and Mayor regarding proposed improvements to animal services infrastructure and animal services operations that may impact the delivery of such improved animal services;
 - (3) Make recommendations to the Board and Mayor regarding public information campaigns and education related to reducing the number of dogs and cats that are abandoned or surrendered to the Miami-Dade Animal Services Pet Adoption and Protection Center;
 - (4) Serve as a forum at which individuals and groups can express concerns and provide suggestions related to reducing the number of dogs and cats that are abandoned or surrendered to the Miami-Dade

Animal Services Pet Adoption and Protection Center; and

- (5) Perform such other duties as may from time to time be assigned to it by the Board of County Commissioners.
- (e) *Applicability of State and County rules and procedures.*
 - (1) All proceedings of the ASAB shall be conducted in accordance with Florida's open government laws, including but not limited to, the Government in the Sunshine Law and the Citizens' Bill of Rights of the Miami-Dade Home Rule Charter. The ASAB shall be deemed an "agency" for the purposes of the State's public records laws.
 - (2) The ASAB shall be governed by article IB of chapter 2, including, without limitation, as to application of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance, section 2-11.1, and the requirement to provide members of the public a reasonable opportunity to be heard on any proposition before the ASAB.
- (f) *Reports*.
 - (1) The ASAB shall prepare, on an annual basis, a written report to the Board of County Commissioners describing the ASAB's activities, and the ASAB's chairperson or vice-chairperson shall appear as needed before the Board to present any matters pertinent to the ASAB.
 - (2) The completed annual reports required by this section shall be placed on an agenda of the full Board without committee review pursuant to rule 5.06(j) of the Board's Rules of Procedure.

Section 2. If any section, subsection, sentence, clause or provision of this ordinance is

held invalid, the remainder of this ordinance shall not be affected by such invalidity.

Section 3. It is the intention of the Board of County Commissioners, and it is hereby ordained that the provisions of this ordinance, including any sunset provision, shall become and be made a part of the Code of Miami-Dade County, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section," "article," or other appropriate word.

Section 4. This ordinance shall become effective ten (10) days after the date of enactment unless vetoed by the Mayor, and if vetoed, shall become effective only upon an override by this Board.
