Subject: Contract Award Recommendation for Caleb Center Curtain Wall HVAC Retrofit and Waterproofing Repairs, Project No. I190016-A

Executive Summary

This item seeks approval from the Board of County Commissioners (Board) to execute a contract award with Florida Construction & Engineering, Inc. (FC&E) for construction services for Project No. I190016-A, Contract No. I190016-A, Caleb Center Curtain Wall HVAC Retrofit and Waterproofing Repairs, for a total contract amount not to exceed \$6,409,307.82. This project helps address needed improvements and creates a sustainable and efficient building with Energy efficient hurricane resistant impact curtain wall and storefronts, addressing building envelope repairs and waterproofing, and providing a more efficient air quality system by retrofitting the existing HVAC and electrical components. The project will replace the existing curtain wall system comprised of the exterior windows and frames, with an energy efficient and hurricane impact resistant system. It also, addresses the building envelope by sealing and waterproofing all exterior walls and finishes. Additionally, it will modernize the existing building systems to create a more resilient and energy efficient building. The improvements bring the building envelope into current code requirements for new construction and help modernized antiquated HVAC systems that will be more energy efficient than the current equipment, further advancing us towards our net zero goals.

Recommendation

It is recommended that the board approve Contract No. I190016-A between Miami-Dade County (County) and FC&E for the Caleb Center Curtain Wall HVAC Retrofit and Waterproofing Repairs, Project No. I190016-A project has been prepared by Internal Services Department (ISD) and is recommended for approval for a maximum value of \$6,409,307.82, which is inclusive of contingency allowance account. Section 2-8.1 (b) of the Code of Miami-Dade County (Code) delegates authority to the County Mayor or County's Mayor designee to award miscellaneous construction contracts if the recommended contract award amount does not exceed \$5,000,000. Solicitations for this construction contract were sent to 177 prequalified general contractors under the County's Miscellaneous Construction Contract 7040 Plan. Because the bid exceeds the \$5,000,000 threshold, Board approval of this contract award recommendation is required.

Delegation of Authority

This item delegates authority to the County Mayor or County Mayor's designee to execute the contract, enforce all provisions and exercise all rights contained therein, including cancellation provisions. This delegation of authority is consistent with those authorities granted under the Code.

PROJECT DESCRIPTION: The purpose of this project is to provide construction services for the selective demolition and removal of asbestos containing materials

(ACM), demolition and removal of existing curtain wall glazing system. (floors 3 – 6). Install new curtain wall system. Demolition of existing store front windows (Mezzanine level and 7th). Install new store front windows. Pressure clean tower, paint entire tower. Remove all existing (floors 4 – 6) electrical outlets. Replace VAV units (floors 3 – 7). Approximately 7 – 10 units per floor. Additional electrical power for new VAV units, new acoustical ceiling, and grid. Remove all existing supply and return air grilles inside the area to be renovated, new ductwork, ductwork to remain to be sealed & capped, any flex connection opening to be abandoned on the main duct as required, test and balance. Electrical work and new panel to operate new mechanical and electrical scope of work. Existing lighting to be installed after new ceiling system is installed. Demolition of any and all partitions required to complete scope of work. Please see phasing plan for scope of work within the drawings. Please review the phasing plan, drawings, and specification for illustration of scope of work. This project scope does not include new interior system furniture and or office partition installation and design under separate permit, ISD Interior Department to specify system, which will be done under a separate permit and project.

EXPLANATION: On April 13, 2023, ISD received and opened one responsive bid. A copy of the Bid Tally is attached in Exhibit A. ISD staff determined that FC&E was the lowest responsive, responsible bidder with a total

maximum contract amount of \$6,409,307.82, which includes ten percent contingency allowance.

FC&E's Base Bid of \$5,826,643.47 is 37 percent above the advertised \$4,247,991.74 estimate, and 5 percent above ISD's \$5,725,017.70 revised estimate for the advertised Scope. The manufacturer advised that the cost of storefront materials for the curtain wall in the advertised scope of work increased from \$1.1 million to \$2.5 million from 2021 to 2023. Additionally, market conditions related to electrical, steel and concrete materials has increased significantly and the projections apply the 2023 and 2024 labor force.

FC&E's bid was forwarded to ISD's Division of Small Business Development (SBD) for a Compliance Review. On August 28, 2023, SBD issued the results of its Compliance Review, finding FC&E to be in compliance. A copy of SBD's Compliance Review showing FC&E's commitment to utilize local subcontractors is attached in Exhibit B.

SBD HISTORY OF VIOLATIONS:

FC&E is eligible to receive this award. FC&E has an open violation dated November 2, 2021 on SBD Violations report for SBE Program Violation – Failed to meet SBE measure on a Parks Recreation and Open Spaces Department (PROS) project (59360218001-1). Although a firm with an SBE makeup plan requirement must submit a makeup plan for any bid/proposal, this requirement does not apply to this contract since this Project is a 100 percent SBE-Con Set Aside and does not require a Goal Deficit Makeup Plan for this Project's Utilization Plan.

DUE DILIGENCE:

Due diligence was performed by ISD in accordance with Resolution No. R-187-12, Resolution No. R-1181-18, and Procurement Guidelines, to determine the Contractor's responsibility, including verifying corporate status, performance, safety records (including Occupational Safety and Health Administration (OSHA) records), and compliance data. The lists that were reviewed include: Sun Biz, convicted vendors, debarred vendors, delinquent contractors, suspended vendors, federal excluded parties, SBD Violations report. The safety records for FC&E and its subcontractors for the last three years were also reviewed. Considering the track-record of the FC&E team's incidents, it was determined that the FC&E team's safety record on the whole should not render them non-responsible for the solicitation of this project. Copies of the FC&E team's OSHA Forms 300/300A are on file and are available upon request. Information was compiled regarding FC&E's prior experience with the County. There are 70 evaluations listed in the Capital Improvement Information System (CIIS) with an average score of 3.4 out of a possible 4.0 points. The firm demonstrates required years of experience in completed project of similar scope. There were no other adverse findings relating to FC&E besides the SBE Program Violation.

PREVIOUS EXPERIENCE WITH COUNTY IN THE LAST THREE YEARS:

According to the Firm History report, as provided by SBD, FC&E has held five Miscellaneous Construction Contracts (MCC) Program contracts as Prime Contractor in the last 3 years, for a total value of \$14,235,973. None of these contracts exceeded \$5,000,000.

The SBD Violations report, CIIS Evaluations report, SBD Firm History report from BMWS are attached as Exhibit C.

Background

The Joseph Caleb Center is located at 5400 NW 22nd Avenue, Miami, Florida 33142. The building has encountered leak issues throughout the years. To maintain operations and reduce disruption to the existing tenants, repairs have been completed on several occasions. In an effort to have a permanent resolution, ISD engaged a consultant to begin investigation, planning and design of the replacement of the curtain wall, storefronts, and provide the necessary waterproofing to address the building leaks. During the design development phases, it was determined that it will be more efficient in the long term for the County to not only address the replacement of the curtain wall with a more efficient system, but to make the necessary retrofits to the mechanical and electrical system since the ceiling will be open at this time. Therefore, the scope of work is to replace VAV units (floors 3 – 7), provide additional Electrical power for new VAV units, new acoustical ceiling, and grid, as well as to remove all existing supply and return air grilles inside the area to be renovated, new ductwork, ductwork to remain to be sealed & capped, any flex connection opening to be abandoned on the main duct as required, test and balance. Electrical work and new panel to operate new mechanical and electrical scope of work was included. This solution provides sustainable benefits by hardening the existing building’s infrastructure, creating a more energy efficient building that meets the County’s Sustainability Plan.

THIS CONTRACT, made and entered into on this ____ day of _____, 2023, by and between Miami-Dade County, Florida, acting by and through the Office of The Mayor, party of the first part (hereinafter sometimes called the "County"), and Florida Construction & Engineering, Inc., party of the second part (hereinafter sometimes called "Contractor");

W I T N E S E T H

That the parties hereto, for and in consideration of the covenants and agreements hereinafter set forth, mutually agree as follows, to wit:

1. 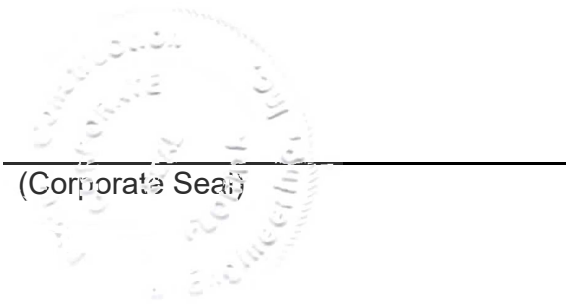
