Subject: Recommendation to Waive Competitive Bidding Procedures and Authorize a Non-

Competitive Purchase for Animal Identification Microchips

## **Summary**

This item is for additional expenditure authority for the Animal Services Department (ASD) to continue purchasing animal identification microchips and other related database services required to be able to identify, track, and register owned and sheltered pets. Animal identification microchips are inserted under the animal's skin and have a unique electronic signature which can be read by a corresponding scanner. Once registered, an animal can be located through national and/or international databases. Through this contract, ASD achieves its mission to return lost pets to their rightful owner, and the microchips are one of the main tools used to accomplish this goal.

#### **Recommendation**

It is recommended that the Board of County Commissioners (Board) waive competitive bidding procedures pursuant to Section 5.03(D) of the Home Rule Charter and Section 2-8.1(b) of the Miami-Dade County Code, by a two-thirds vote of the Board members present and authorize additional expenditure authority of \$40,000 to *Contract No. BW-10135, Animal Identification Microchips*, for ASD. The County awarded this non-competitive bid waiver contract under delegated authority on December 2, 2021, for a three-year term. Current research indicates that the market for the provision of animal identification microchips is competitive. The County is in the process of drafting specifications to establish a replacement contract.

#### **Background**

The provision of microchips is of utmost importance to the community to decrease the lengths of stay for lost pets at the shelters and increase the number of pets that are returned to their owner. Pethealth Services (USA), Inc. (Pethealth) is the current provider of microchips and database services. Their responsibilities include a quality review of pet owner registration data to determine pet owners that are pending registration. Under the contract, this quality assurance review and data verification process is ongoing and is being performed free of charge to the County and community pet owners.

Additional expenditure authority is needed as the demand for these products has increased above initial projections through the animal wellness clinic and community outreach events. Additionally, the number of pets entering the shelter that require a microchip implanted prior to adoption has increased the sales of the product for pet owners.

A bid waiver is requested to ensure continuity of services for the remainder of the contract term while a competitive solicitation is advertised, and a replacement contract awarded. This bid waiver contract was established with Pethealth to allow for the ongoing quality review of pet owner registrations and to increase microchip registrations and lost-pet reunifications. Pethealth offers free lifetime membership to pet owners, which contributes to those objectives, as fees to owners are recognized as a barrier to registration. Accordingly, it is in the County's best interest to approve this bid waiver request pursuant to Section 2-8.1(b)(1) of the Miami-Dade County Code and Section 5.03(D) of the Home Rule Charter to continue purchasing microchips, related products, and associated services.

#### **Scope**

The impact of this item is countywide in nature.

### **Delegated Authority**

The County Mayor or the County Mayor's designee will have the authority to exercise all provisions of the contract, including any cancellation or extensions, pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

#### Fiscal Impact/Funding Source

The contract term expires on December 1, 2024. The contract has a current cumulative allocation of \$232,800. If this request is approved, the contract will have a modified cumulative allocation of \$272,800. The requested increase in expenditure authority is based on costs associated with microchips, microchip injectors, scanners, and database registry services. The department's request is based on approximately 10,000 microchips to cover the department's anticipated operational needs.
