Subject:	Recommendation to Award a Contract for Lifeguard To-	wers for Crandon Park Beach

Summary

This item is for the purchase of lifeguard towers for Crandon Park Beach for the Miami-Dade Fire Rescue Department (MDFR). The contract will provide for the assembly and delivery of lifeguard towers for Crandon Park Beach. Approval of this item will allow MDFR to purchase aluminum lifeguard towers to replace the 13 deteriorating wood constructed towers. The lifeguard towers are an essential tool for lifeguard personnel to be able to accomplish their mission of safeguarding individuals that visit Crandon Park Beach in Miami-Dade County.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve a competitive contract award, *Contract No. EVN0000579, Lifeguard Towers for Crandon Park Beach*, to Bausch Enterprises, Inc. for MDFR in the amount of \$1,065,350 for a three-year term. This contract supplements *Contract No. FB-01719* which was awarded under delegated authority in 2021 for 17 lifeguard towers at Haulover Beach. Under the previous solicitation *FB-01719*, the County advertised for the 17 lifeguard towers with the option to add 13 towers prior to the 17th tower being delivered to MDFR. However, when the vendor was contacted to exercise the option, the vendor advised that they were unable to hold the price due to changing market conditions as a result of the pandemic.

Background

On June 20, 2023, an Invitation to Bid (ITB) was issued under full and open competition for the purchase of 13 lifeguard towers. Upon advertisement of the solicitation in INFORMS, 11 vendors were notified, of which one viewed and downloaded the solicitation. Vendors notified included those identified during the market research, that are doing business under the related category codes, or participated in recent solicitations issued by other municipalities in Florida. On July 12, 2023, one bid from a non-local firm was received in response to the solicitation.

A survey was conducted, due to the limited participation, to inquire whether barriers existed in the decision not to compete/submit a bid for the requested goods. Ten vendors were contacted for feedback as they were identified as having been invited to the solicitation in INFORMS. Three vendors responded with feedback to the survey, indicating their company does not offer the goods or services requested.

<u>Scope</u>

Crandon Park Beach is located within District 7, which is represented by Commissioner Raquel Regalado; however, the impact of this item is countywide.

Fiscal Impact/Funding Source

The fiscal impact for the three-year term is \$1,065,350. The current contract is valued at \$977,500 for a three-year term and expires on January 24, 2024. The allocation under the replacement contract is higher than the current contract due to the higher pricing resulting from the current market conditions. The difference in unit price between the current and the new contract is \$24,450. Staff attempted to negotiate pricing with the recommended vendor but were unsuccessful.

Track Record/Monitor

Manuel Jimenez of the Strategic Procurement Department (SPD) is the Procurement Contracting Manager.

Delegated Authority

If this item is approved, the County Mayor or County Mayor's designee will have the authority to give notice of this award to the recommended vendor, issue the appropriate purchase orders to give effect to same and exercise all provisions of the contract, including any cancellation or extensions, pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

Vendor Recommended for Award

Pursuant to Resolution No. R-477-18, the lowest bidder is recommended in accordance with the method of award per the solicitation and is non-local. Outreach was conducted to identify local vendors who could participate in this solicitation; however, due to MDFR's standardization requirements to have all towers of the same material, no local vendors were identified which could meet the requirements.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with SPD's Procurement Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues through various vendor responsibility lists and a keyword internet search. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to vendor responsibility.

Pursuant to Resolution No. R-140-15, a full review of the scope of services was conducted to ensure the solicitation reflects the County's current needs. The review included conducting market research, posting a draft solicitation for industry comments, and holding meetings and drafting sessions with the user department. The scope of services was modified to remove the vendor's responsibility for the relocation and installation of the towers on the beach.

- The Small Business Enterprise Bid Preference and Local Preference were applicable.
- The Living Wage Ordinance does not apply.
