Subject:	Recommendation to Waive Competitive Bidding Procedures and Authorize a Non- competitive Purchase to Exercise the Four Renewal Terms and for Additional Expenditure Authority for Code Compliance Body Worn Cameras		

<u>Summary</u>

This item is seeking approval to exercise the four available one-year option to renew terms and additional expenditure authority under this bid waiver contract to allow the Department of Regulatory and Economic Resources (RER) to continue purchasing software licenses, maintenance, support services for the usage of body worn cameras. Body worn cameras are necessary for use by RER's field staff for their protection and to assist with case documentation. It has been observed that the migration of cameras has played a pivotal role not only in the direct resolution of customer disputes, but also in the broader spectrum of enhancing customer service. RER's Code Compliance Division has noticed a drop in customer service complaints and requests for meetings with supervisors since the inception of the program.

Recommendation

It is recommended that the Board of County Commissioners (Board) waive competitive bidding procedures by a two-thirds vote of the Board members present pursuant to Section 2-8.1(b) of the Code of Miami-Dade County, Florida (County Code) and Section 5.03(D) of the Home Rule Charter to exercise the four, one-year option to renew terms and authorize \$466,560 in additional expenditure authority under *Contract No. BW-10272, Code Compliance Body Worn Cameras*, for RER. By doing so, RER will be able to continue purchasing software licenses, maintenance, and support services for the body worn cameras during these terms. This non-competitive bid waiver contract was approved under delegated authority on December 30, 2022, and awarded to Axon Enterprise, Inc. (Axon) for a one-year term with an allocation of \$250,000. The contract has not been modified since its inception. Board approval is required as the four, one-year option to new terms exceed the County Mayor's delegated authority.

Background

RER primarily utilizes this contract to improve case management documentation and promote safe encounters between the Code Compliance Division's field officers and the public as it relates to code enforcement matters, either because of a complaint or reinspection of a location that was found in violation, among many other reasons. Code enforcement field work requires staff to be very precise with case documentation and often times requires staff to diffuse difficult situations. In summary, body worn cameras act as a deterrent for further escalation, as interactions are recorded as well as provide the most accurate form of case management documentation since field officers can narrate and record relevant information pertaining to the case.

For the aforementioned reasons, RER decided to explore the use of body worn cameras. Axon was brought to the attention of RER by other code enforcement agencies, such as the City of Doral, City of Miami Beach, Miami-Dade Police Department and Miami-Dade Corrections and Rehabilitation Department, which use this vendor exclusively. Prior to entering into this agreement, RER engaged in a no-cost pilot agreement, *Contract No. PP-10272*, with Axon to test the products and services offered. Upon conclusion of the pilot agreement, RER desired to engage in this bid waiver agreement to continue receiving services.

Over the past year, RER's Code Compliance Division staff have worked and communicated with the vendor for on-going support, and the company has shown itself to be uniquely qualified to provide this product as they specialize in this type of equipment and service. Axon possesses a wealth of knowledge and expertise about the use of body worn cameras for law enforcement and code enforcement purposes, which is an asset as the Code Compliance Division. RER desires to continue receiving services from Axon to protect its compliance officers during the course of their work. Due to the success thus far with the use of body worn cameras, RER is looking to expand their use to other field operations.

As such, it is in the County's best interest to waive competitive bidding requirements pursuant to Section 2-8.1(b) of the County Code and Section 5.03(D) of the Home Rule Charter to ensure continuity of services and to maintain product standardization within the County.

<u>Scope</u>

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The contract term expires on December 31, 2023 and has a current cumulative allocation of \$250,000. If this request is approved, the contract will have a modified cumulative allocation of \$716,560 and will expire on December 31, 2027.
