#### Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Century Palms East is bounded on the north by SW 18 Street, on the east by SW 144 Avenue, on the south by SW 19 Street, and on the west approximately 360 feet east of SW 145 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

#### **Scope**

This plat is located in Commission District 11, which is represented by Commissioner Roberto J. Gonzalez.

#### **Delegation of Authority**

#### Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the county would be approximately \$450.00 annually for the maintenance of new roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.


