	RESOLUTION HONORING YOTUE DESCEMER BUENO, GENTE DE	,

WHEREAS, the 22nd Annual Latin Grammy Awards took place on November 18, 2021, to honor the best musical releases in Latin music between June 1, 2020, and May 31, 2021; and

OTERO ALCÁNTARA, MAYKEL OSORBO, AND DJ EL

FUNKY FOR THEIR WORK ON "PATRIA Y VIDA"

WHEREAS, at that awards ceremony, the song "Patria y Vida" was named the "Song of the Year" from a pool of a dozen nominees; and

WHEREAS, "Patria y Vida" is a reggaeton song that was released in February 2021 by Yotuel Omar Manzanares Romero (popularly known as "Yotuel"), Beatriz Luengo, Descemer Bueno, Gente de Zona (a duo comprised of Alexander Delgado and Randy Malcom), Luis Manuel Otero Alcántara, Maykel Osorbo, and DJ El Funky; and

WHEREAS, the title of the hit song was devised by the San Isidro Movement—a group of Cuban artists, journalists, and academics that was formed in 2018 to protest the Cuban dictatorship's censorship of artistic expression—which has been the target of arrests and retaliation by the Cuban government; and

WHEREAS, the title of the song is a play on a Cuban communist motto, "Patria o Muerte" ("Homeland or Death"), inverting the communist message to one of hope and expectation, "Homeland and Life"; and

WHEREAS, in the summer of 2021, fueled by the despair caused by decades of oppression, the Cuban people took to the streets, calling for an end to communism in Cuba and for access to the basic life-sustaining needs that they have lacked—food, medicine, water, and electricity—because of the failed communist policies of the Cuban regime; and

WHEREAS, "Patria y Vida" became a rallying cry and anthem for the Cuban people as they stood up to the 60-year-old oppressive regime; and

WHEREAS, the lyrics of the song encapsulate many of the grievances that the Cuban people hold against their despotic government, including the cruelty of the Cuban regime towards its citizens; its censorship of truth and artistic expression; the scarcity of food; and the years of failed policies that have led people to risk their lives to flee the country, leaving behind saddened mothers; and

WHEREAS, this Board desires to honor the artists behind "Patria y Vida" not only for their accolade at the 2021 Latin Grammys, but also for inspiring those rising up against the Cuban government and giving music to the movement for freedom in Cuba,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby honors Yotuel, Beatriz Luengo, Descemer Bueno, Gente de Zona, Luis Manuel Otero Alcántara, Maykel Osorbo, and DJ El Funky for their work on "Patria y Vida."
