#### RESOLUTION NO.

RESOLUTION URGING THE FLORIDA LEGISLATURE TO ENACT SENATE BILL 48, OR SIMILAR LEGISLATION THAT WOULD PROTECT THE RIGHTS OF MINORS, SENIORS, AND INCAPACITATED PERSONS BY PROVIDING ADDITIONAL GUIDELINES AND PROCEDURES APPLICABLE TO THE PRESIDING COURT, THE COURT-APPOINTED GUARDIAN, AND THE WARD'S FAMILY MEMBERS

WHEREAS, on September 18, 2023, Senator Ileana Garcia (R – Miami) introduced Senate Bill ("SB") 48 for consideration during the 2024 session of the Florida Legislature; and

**WHEREAS**, SB 48 is titled "Karilyn's Law" and amends several Florida Statutes related to guardianship of minors and incapacitated persons; and

WHEREAS, among other provisions, SB 48 would require guardians for alleged incapacitated persons or minors to be appointed on a rotating basis, require courts to establish visitation of a minor's family and of an incapacitated person's family, and require that courts seeking to deny visitation rights for a minor base this denial on a showing of clear and convincing evidence that visitation is not in the best interest of the minor; and

WHEREAS, SB 48 further authorizes the suspension of power of attorney prior to an incapacity determination based on a jury determination; requires a guardian of a ward's property to file a verified inventory and annual accounting with the court that must be made available to the ward's family, the ward's next of kin, and the beneficiaries and heirs of the ward's valid will; and requires a reevaluation of the need for guardianship every three years for a person who has been determined to be incapacitated, to be presided over by a different judge than the one who handled the initial incapacitation hearing; and

WHEREAS, this Board is supportive of changes to Florida law which will protect the rights of minors, seniors, and incapacitated persons in Miami-Dade County,

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

<u>Section 1.</u> Urges the Florida Legislature to enact Senate Bill 48, or similar legislation that would protect the rights of minors, seniors, and incapacitated persons by providing additional guidelines and procedures applicable to the presiding court, the court-appointed guardian, and the ward's family members.

Section 2. Directs the Clerk of the Board to transmit certified copies of this resolution to the Governor, the Senate President, the House Speaker, Senator Ileana Garcia, and the Chair and remaining Members of the Miami-Dade County State Legislative Delegation.

Section 3. Directs the County's state lobbyists to advocate for the actions set forth in section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2024 State Legislative Package to include this item.

The Prime Sponsor of the foregoing resolution is Commissioner Juan Carlos Bermudez. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
