Executive Summary

This item recommends approval of additional expenditure authority of \$15,938,574 to the County's contract with New Flyer of America, Inc. to enable the Department of Transportation and Public Works (DTPW) to purchase charging infrastructure equipment and associated services required to operate the forthcoming fleet of battery-electric buses along the South Corridor. The purchase is critical as it will facilitate the timely completion of the South Dade Transit Operations Center which is required for the battery-electric fleet to be used for Bus Rapid Transit (BRT) along the South Dade TransitWay.

The contract currently includes the manufacturing and delivery of 100 heavy duty 60-foot battery-electric low floor transit buses and 50 depot-based chargers, but did not include the charging infrastructure equipment, including the power receptacles for the chargers and the power dispensers to connect the chargers to the battery-electric buses. The charging infrastructure equipment was not originally included under this contract because it was expected to be supplied as part of the completion of the Operations Center, which will come online after service has already begun operation.

However, through further research and analysis, it was determined that New Flyer was also a potential source to supply the charging infrastructure equipment. It was also determined that using New Flyer as that source would provide significant operational efficiencies, highly favorable pricing, and provide expedited delivery of equipment to meet the timeline for the opening of the South Dade Transit Operations Center despite global supply chain issues. Accordingly, under this item, New Flyer will provide DTPW additional charging infrastructure equipment as well as delivery, commissioning, testing, and training services, ensuring the electric fleet can effectively operate along the TransitWay.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve this request for increased spending of \$15,938,574 as a designated purchase under *Contract No. RFP-01966*, *Heavy Duty 60-Foot Battery-Electric Low Floor Transit Buses*, for DTPW to purchase charging infrastructure equipment and associated services. The County awarded this competitively-established contract through Resolution No. R-30-23 on January 17, 2023 for a value of \$175,594,364 for a five-year term to New Flyer of America, Inc. At the time of the advertisement, not all vendors in the industry could provide charging infrastructure equipment. Therefore, to avoid restricting competition in the solicitation in a field that already had limited providers, these components were not included in the scope. Because the charging infrastructure equipment was not included in the scope of the original solicitation, approval of a designated purchase, by a two-thirds vote of the Board members present, is being requested pursuant to Section 2-8.1(b)(3) of the Miami-Dade County Code.

It was originally anticipated that the equipment and services would be acquired from the contractor selected to construct the South Dade Transit Operations Center to avoid limiting competition on the electric bus acquisition. However, further industry research identified New Flyer as a potential source of supply. Upon staff analysis and review by external consultants, it was determined that using this contract as the purchasing mechanism will allow DTPW to manage all aspects of the battery-electric bus charging infrastructure through a single responsible party, providing consistent warranty provisions across all components and a single point of contact for technical support issues, thus providing significant operational efficiencies over entering into multiple separate contracts for various components of the infrastructure.

Additionally, lead times for production and delivery of the equipment have been extended as a result of global supply chain issues. New Flyer is able to work directly with the source of supply for the equipment and leverage existing industry relationships to provide expedited delivery to meet the timeline for the opening of the South Dade Transit Operations Center.

Further, industry research has indicated that the pricing provided by New Flyer represents highly favorable costs to the County. To obtain a valuation of the recommended purchase and ensure best value, the equipment and services were included as an optional item in *Solicitation No. CIP227A-DTPW22-CT* for the construction of the South Dade Transit Operations Center. To meet the timeline for completion of the South Dade Transit Operations Center, due to the extended lead time for this equipment, this item was prepared in parallel with the advertisement of that solicitation. A supplement to this item will be submitted to provide confirmation of savings to be achieved via this designated purchase. In the event that pricing received is lower than the pricing provided by New Flyer, withdrawal of this item will be requested.

Therefore, purchase via formal sealed bids is not practicable at this time because of the anticipated higher cost to the County, operational impacts resulting from managing multiple contracts, performance risk associated with multiple service providers, and potential impacts to delivery timelines. Accordingly, it is in the County's best interest to approve this designated purchase pursuant to Section 2-8.1(b)(3) of the Miami-Dade County Code.

This item is placed for Board review pursuant to Miami-Dade County Code Section 29-124(f). The Board may only consider this item if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the Board. If CITT has not forwarded a recommendation and 45 days have not elapsed since the issuance of this recommendation, a withdrawal of this item will be requested.

<u>Scope</u>

The impact of this item is countywide in nature as the South Dade TransitWay promotes connectivity to the entire transit system.

Delegated Authority

The County Mayor or the County Mayor's designee will have the authority to execute Supplemental Agreement No. 1 to *Contract No. RFP-01966* and exercise all provisions thereof pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

Fiscal Impact/Funding Source

The contract term expires on January 24, 2028. The contract has a current cumulative allocation of \$175,594,364 which was funded via Federal Transit Administration (FTA) Funds, State Funds, and Lease Financing. If this request is approved, the contract will have a modified cumulative allocation of \$191,532,938. The additional allocation in the amount of \$15,938,574 is funded through People's Transportation Trust (PTP) Funds. The requested increase in expenditure authority is based on price analysis and negotiations and includes funds for the purchase of optional items as well as a contingency.

Whereas, the County desires to purchase Additional Services and associated equipment in accordance with the provisions of the subject Contract; and,

Whereas, the Contractor has agreed to provide such Additional Services and associated equipment in accordance with the subject Contract and Attachment 1, Statement of Work, attached hereto; and,

Whereas, the parties acknowledge that no federal or state funds will be used for the purchase of such Additional Services and associated equipment; and,

Whereas, the parties wish to establish an equitable payment schedule for the provision of such Additional Services and associated equipment in accordance with Attachment 2, Pricing and Payment Schedule; and,

Now therefore, the parties agree to the following:

- 1. Attachment 1, Statement of Work, and Attachment 2, Payment Schedule, attached hereto, shall be incorporated into the subject Contract.
- 2. Article 1 is hereby revised to incorporate the following definition: The words "County Approval" to mean the County's written notification to the Contractor that all Additional Services, including any punch list items, have been completed and the associated products have been successfully functioning in accordance with the specifications for a period of 30 consecutive days. Such County Approval will not be unreasonably withheld or delayed.
- 3. Article 7 is hereby revised to state the following: The compensation for all Work and Services, inclusive of Additional Services performed under this Contract, including all costs associated with such Work and Services, shall be in the total amount of One Hundred Ninety Million Seven Hundred Fifty-Four Thousand Five Hundred Eighty-Three Dollars and Sixty-Two Cents (\$190,754,583.62). The County shall have no obligation to pay the Contractor any additional sums in excess of this amount, except for as otherwise allowable under the terms of the Contract or as a result of a change and/or modification to the Contract, which is approved and executed in writing by the County and the Contractor.
- The provisions of Article 8 shall not apply to purchases completed under this Supplemental Agreement 1.
- Payment for the Additional Services and associated products outlined in Attachment 1, Statement of Work, shall be completed in accordance with Attachment 2, Pricing and Payment Schedule, attached hereto.

In the event of such termination the Contractor agrees and acknowledges that it may not be awarded a public contract for at least one (1) year from the date of such termination and that Contractor shall be liable for any additional costs incurred by the County because of such termination.

In addition, if County has a good faith belief that a Subcontractor has knowingly violated any provisions of Sections 448.09(1) or 448.095, Florida Statutes, but Contractor has otherwise complied with its requirements under those statutes, then Contractor agrees that it shall terminate its contract with the Subcontractor upon receipt of notice from the County of such violation by Subcontractor in accordance with Section 448.095(5)(c), Florida Statutes.

ATTACHMENT 1 - STATEMENT OF WORK

1. Additional Services to be Provided

The Contractor shall furnish, deliver, perform cold testing, hot testing, commissioning, acceptance, provide in-person training, technical support and warranty as described in this Section 1 for the Equipment to be Provided (See Section 2) in accordance with the provisions of this Statement of Work. For avoidance of doubt, civil work, construction, and installation are outside of the scope of this Statement of Work as outlined in Table 1 below, which defines responsibilities of the Contractor and the County (via its Construction Contractor for the South Dade Transit Operations Center.)

1.1. Cooperation and Project Management

The Contractor shall fully cooperate with the County and any third-party contractor(s) or subcontractor(s) which may be selected as a result of County Solicitation No. CIP227 A-DTPW22-CT, South Dade Transit Operations Center, and any subsequent solicitation issued for services related to the South Dade Transitway En Route Equipment, including coordination of schedules for delivery, commissioning, testing, and training required to achieve County Approval. The Contractor shall assign a dedicated project manager for the duration of Services under this Supplemental Agreement. Responsibilities of the project manager shall including, but are not limited to: attending cadence coordination meetings as required by the County, providing/coordinating timely technical support during the equipment installation, testing, commissioning and warranty periods, maintaining a project schedule which includes all key milestones and critical path items, and advising the County weekly of the status of the project.

Further, the Contractor shall coordinate with all subcontractors, manufacturers, and suppliers. All provisions of Article 20, Subcontractor Relations, shall apply.

1.2. Furnish and Deliver

The Contractor shall supply all equipment as identified in Section 2, including any ancillary components needed for the equipment to function in accordance with the provisions of this Statement of Work. Such equipment shall

be delivered to a site as designated by the County in accordance with the applicable Project Schedule identified herein, as may be subsequently modified upon mutual agreement of the parties. At the time of delivery, the Contractor shall inventory all equipment provided, subject to verification by the County, and provide a complete inventory listing to the County. The Contractor shall retain title of ownership, including all liabilities thereof, until such time as the County confirms receipt of delivery and receipt of the valid inventory listing. Such confirmation shall occur within 14 calendar days.

1.3. Testing and Commissioning

Contractor to conduct and be responsible for all aspects of equipment testing as required by Manufacturer, including any mutually agreed upon updates thereof, including but not limited to: cold testing, hot testing, remote testing, troubleshooting, verification and adequacy checks. During commissioning, Contractor shall schedule and conduct all commissioning events as required by Manufacturer in order to confirm equipment provided is delivering the required changing results in the time allotted contractually. Contractor Project Manager is to provide all related testing and commissioning documentation for site contractor concurrence and DTPW acceptance, as part of equipment testing, commissioning, acceptance, safety certification and permitting-related requirements under the site contractor.

1.4. Training

Contractor to provide in-person training to all DTPW staff, imparting training sessions to the day and night shifts during the three (3) working shifts (shift times are: 6am to 2pm, 2pm to 10pm and 10pm to 6am). All training sessions shall include at least one in-person trainer, in-classroom theory and equipment hands-on training. Trainer must be certified by the equipment manufacturer to impart such training. All classes shall provide hard copies of all training manuals to each participant and an all-inclusive digital copy submitted to the DTPW Project Manager.

1.5. Warranty and Preventative Maintenance

The Contractor shall provide a 12 year warranty for all equipment beginning on the date of County Approval Such warranty shall be in conformance with the provisions of Attachment A, TECHNICAL SPECIFICATIONS, WR 1 and WR 2, Warranty Requirements of the Contract. Further, the Contractor shall provide preventative maintenance for the duration of the warranty period in accordance Annual Preventative Maintenance per Heliox standard procedures, attached hereto as Attachment 3.

1.6. Equipment Technical Support

From equipment acceptance and upon commissioning, Contractor will provide technical support for all equipment provided to monitor, troubleshoot, repair, etc. any warranty items that may arise at no cost to the County. Items beyond warranty will be discussed and agreed with the County prior to performing the work so that cost is agreed upon in advance. The term for technical support services is 36 months.

1.7. Equipment Storage

All equipment is to be delivered by the Contractor in accordance with the applicable Project Schedule. Should equipment be ready for delivery while installation site is not ready to commence installation, the County will provide an alternative location for storage of the equipment. The Contractor shall provide specifications for the storage location including any necessary environmental conditions and shall inspect such location and provide written confirmation that such location is suitable for the storage of the equipment. The County will maintain the location in the same condition as was present on the date of written confirmation. In accordance with Section 1.2, the Contractor shall conduct an inventory of equipment delivered. The County shall be liable for any damage to the equipment while in storage.

Upon notification by the County that the installation site is ready to commence installation, the parties shall mutually agree to date on which the Contractor shall relocate the equipment to the installation site. The Contractor shall be liable for any damage to the equipment that occurs during relocation of the equipment. The inventory process shall be repeated upon delivery to the installation site.

 - b. Systems that employee a single larger kW cabinet with multiple outputs to dispensers that produce the total output charge power of the nominal 180kW minimum and charger time are acceptable and considered equivalent to a single 180kW cabinet unit.
- **3.2.** Inverted pantograph charging dispensers shall be capable of charging full quantity of overhead electrically charged vehicles in a single consecutive (8) eight-hour period minimum, assuming full power is made available. Additional chargers provided in maintenance and services bays are not to be factored in to charging systems ability to charger the identified BEB fleet size in an eight-hour period.
