RESOLUTION URGING THE FLORIDA LEGISLATURE TO APPROPRIATE FUNDING FOR THE ESTABLISHMENT OF (1) THE MIAMI-DADE COUNTY TALENT ATTRACTION AND RETENTION PILOT PROGRAM AND (2) THE SOUTH FLORIDA INSTITUTE FOR ECONOMIC RESEARCH

WHEREAS, the Miami-Dade Beacon Council (the "Council"), a public-private partnership, is the official economic development organization for Miami-Dade County (the "County"); and

WHEREAS, the Council was founded in 1985 as an outgrowth of the Greater Miami Chamber of Commerce to focus on business recruitment, expansion, and retention; and

WHEREAS, today the Council facilitates business growth and expansion locally, nationally, and internationally; and

WHEREAS, the County has experienced significant industry growth and is becoming a leader in cyber-security, artificial intelligence, financial services and technology, aviation, and corporate operations (the "targeted industry sectors"); and

WHEREAS, the County has an unemployment rate of 1.6 percent, which is almost a third of the national rate of 3.9 percent; and

WHEREAS, for the County to continue its economic and business growth, expansion, and retention, the Council is pursuing funding to create (1) the Miami-Dade County Talent Attraction and Retention Pilot Program and (2) the South Florida Institute for Economic Research ("SFIER"); and

WHEREAS, the retention of college and graduate students who are already in the County, and targeted attraction of people with skills that are in demand, will reduce workforce shortages, reduce the loss of talent from leading universities in the County, and position the County as a leader in the targeted industry sectors; and

WHEREAS, as part of the pilot program, the Council will engage industry-leading companies in the fields of the targeted industry sectors to learn the necessary skills, certifications, and degrees they need and anticipate needing in the future; and

WHEREAS, additionally, the pilot program will deepen collaboration among the universities in the County; and

WHEREAS, the SFIER will serve as an appendage to the Council, providing updated and accurate data, research, and analysis on current trends impacting the South Florida economy, as well as annual economic forecasts, for the public, private, and nonprofit sectors; and

WHEREAS, with this data and information, the SFIER will be paramount in creating informed solutions to the economic challenges facing the County and South Florida, such as job creation and workforce training, among others; and

WHEREAS, this Board wishes to pursue all available funding for the establishment of (1) the Miami-Dade County Talent Attraction and Retention Pilot Program and (2) the South Florida Institute for Economic Research.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature to appropriate funding for the establishment of (1) the Miami-Dade County Talent Attraction and Retention Pilot Program and (2) the South Florida Institute for Economic Research.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, the Senate President, the House Speaker, and the Chair and members of the Miami-Dade County State Legislative Delegation.

Section 3. Directs the County's state lobbyists to advocate for the action described in Section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2024 State Legislative Package to include this item.
