This substitute differs from the original in that it contains revised language in the Background section related to the approved use of \$3,750,000 in grant fund dollars awarded to the County under Award Number 15JCOPS-23-GG-01895-TECP.

Executive Summary

This item, pursuant to the terms of Resolution No. R-663-21, seeks to ratify the execution of grant agreements, attached to the resolution and labeled as Exhibit A, Exhibit B, and Exhibit C, for grant awards from the federal government for more than \$1,000,000, accepted by the Miami-Dade Police Department (MDPD) on behalf of Miami-Dade County (County):

- Exhibit A: Project Title - Miami-Dade Police Department Hate Crimes and Prevention and Prosecution Program, Award Number 15PBJA-23-GG-05351-HATE, Federal Award Amount \$1,600,000
- Exhibit B: Project Title - Operation Safe Ride, Award Number 15PBJA-22-GG-00073-BRND, Federal Award Amount \$2,010,000
- Exhibit C: Project Title FY23 COPS Technology and Equipment Program (Congressionally Directed Spending), Award Number 15JCOPS-23-GG-01895-TECP, Federal Award Amount \$3,750,000

Recommendation

It is recommended, pursuant to the terms of Resolution No. R-663-21, that the Board of County Commissioners (Board) ratify the County Mayor or County Mayor's execution of grant agreements for the following grant awards from the federal government for more than \$1,000,000:

- Exhibit A: Project Title - Miami-Dade Police Department Hate Crimes and Prevention and Prosecution Program, Award Number 15PBJA-23-GG-05351-HATE, Federal Award Amount \$1,600,000
- Exhibit B: Project Title - Operation Safe Ride, Award Number 15PBJA-22-GG-00073-BRND, Federal Award Amount \$2,010,000

- Exhibit C: Project Title FY23 COPS Technology and Equipment Program (Congressionally Directed Spending), Award Number 15JCOPS-23-GG-01895-TECP, Federal Award Amount \$3,750,000

Scope

The impact of this item is countywide.

Delegation of Authority

Pursuant to Resolution No. R-663-21, the County Mayor or County Mayor's designee is authorized, subject to ratification by the Board, to execute grant agreements for grant funds in the amount \$1,000,000.00 or greater.

Fiscal Impact/Funding Source

These grant awards described above do not require a local cash or in-kind match. As such, these grant awards will not create a fiscal impact to the County.

Track Record/Monitor

Assistant Director Gustavo Knoepffler, of the MDPD's Fiscal & Departmental Services, will track and monitor these grants.

Background

On July 8, 2021, the Board adopted Resolution No. R-663-21, directing the County Mayor or County Mayor's designee to actively pursue and apply for federal and state grants and further authorizing the County Mayor or County Mayor's designee to apply for, receive, and expend federal and state grant funds on the County's behalf, without prior approval, provided that: (1) the grant does not require the provision of new funds to match the grant funds, and the administration does not need to seek any funding authorization from this Board in connection with the grant; (2) the terms of the grant will not hinder the County from seeking other funds; (3) at the time of award, the grant does not require the execution of a contract with an entity other than the granting agency; and (4) the granting agency does not require Board approval. Resolution No. R-663-21 provides that, for any grant agreements executed under the authority of this resolution, where the amount of grant funds is \$1,000,000.00 or greater, the County Mayor or County Mayor's designee shall seek ratification by this Board. Pursuant to the terms of Resolution No. R-663-21, the MDPD seeks to ratify the execution of the following grant agreements:

- Exhibit A: Project Title - Miami-Dade Police Department Hate Crimes and Prevention and Prosecution Program, Award Number 15PBJA-23-GG-05351-HATE, Federal Award Amount \$1,600,000
- Exhibit B: Project Title - Operation Safe Ride, Award Number 15PBJA-22-GG-00073-BRND, Federal Award Amount \$2,010,000
- Exhibit C: Project Title FY23 COPS Technology and Equipment Program (Congressionally Directed Spending), Award Number 15JCOPS-23-GG-01895-TECP, Federal Award Amount \$3,750,000

The following are brief descriptions of each grant program/project awarded to the County, through the MDPD, and accepted under the authority of Resolution No. R-663-21:

- Exhibit A: The \$1,600,000 in grant funds awarded to the County, through the MDPD, under Award Number 15PBJA-23-GG-05351-HATE will be used to implement the MDPD's Hate Crimes Prevention and Investigation Program (Program). In 2022, the MDPD, in partnership with the Miami-Dade State Attorney's Office (SAO), established the Hate Crime & Elderly Exploitation Task Force (Task Force). The Task Force's primary focus is prevention, detection, and prosecution for hate crime and elderly exploitation related cases. Each MDPD District and Bureau have an assigned Hate Crime & Elderly Exploitation Liaison. The Task Force reviews, advises, and guides investigators on key elements needed that are indicative of a hate crime. The MDPD will use awarded grant funds to expand the work of the Task Force through its proposed Program. The Program will consist of key partners such as the SAO, the Federal Bureau of Investigation, Florida International University, community-based organization Survivor's Pathway, the Miami Police Department, the Homestead Police Department, and the Miami Beach Police Department working together on public outreach, educational campaigns, hate crimes training for police officers, and enhanced criminal investigations.
- Exhibit B: The \$2,010,000 in grant funds awarded to the County, through the MDPD, under Award Number 15PBJA-22-GG-00073-BRND will be utilized by the MDPD to implement its Operation Safe Ride program (Safe Ride). Safe Ride's goal is the reduction of crime on Miami-Dade Transit (MDT) systems, Metrorail and Metromover, through increased high-visibility police patrols. The goal of Safe Ride is to deter, and decrease crime from occurring on MDT platforms, as well as on trains and shuttles. Direct services will include enhanced police services and coverage on public transit, which will lead to faster response times to calls for service and an overall reduction of incidents occurring on MDT.
- Exhibit C: The \$3,750,000 in grant funds awarded to the County, through the MDPD, under Award Number 15JCOPS-23-GG-01895-TECP will be utilized by the MDPD to implement its Mobile Computing Upgrade project. This project will ensure all MDPD officers have the latest and most up-to-date equipment and technology while on the road and in the field. The MDPD plans to utilize these awarded grant funds to upgrade laptops for in-vehicle computing, as well as to provide access to all applications. MDPD officers rely on mobile computers for computer-aided dispatch systems; collecting and securely transmitting crime data; processing surveillance videos from a variety of sources such as webcams, drones, and street cameras; and running statistics. MDPD's Mobile Computing Upgrade program will also provide immense cost-savings by using modular instead of conventional laptops.





Contracts and/or MOUs with Other Jurisdictions: Items funded under this award must only be used for law enforcement activities or services that benefit your agency and the population that it serves and cannot be utilized by other agencies unless the items benefit the population that your agency serves.

Build America, Buy America Act (BABAA): To the extent that provisions found in Pub. L. No. 117-58, §§70901-52, as supplemented by OMB guidance M-22-11 (April 18, 2022) are applicable, recipients must use iron, steel, manufactured products, and construction materials produced in the United States for any infrastructure projects funded under this award unless they first request and obtain a waiver from the Office of Community Oriented Policing Services (COPS Office).

The Build America, Buy America Act (BABAA), Pub. L. No. 117-58, §§70901-52, requires all federal agencies, including the COPS Office, to ensure by May 14, 2022, that no federal financial assistance for "infrastructure" projects is provided "unless all of the iron, steel, manufactured products, and construction materials used in the project are produced in the United States."

In accordance with section 70914 of the BABAA, COPS Office recipients receiving funding for infrastructure projects (e.g., construction, renovation, and broadband infrastructure) may not use their grant funds for these infrastructure projects or activities unless they comply with the BABAA sourcing requirements or request and obtain a waiver of the requirements from the COPS Office.

The COPS Office may approve, subject to notice and comment requirements and OMB review, the following types of waivers in accordance with sections 70914(b) and (d), 70921(b), 70935, and 70937 of the Build America, Buy America Act:

1. Nonavailability Waivers – Waivers addressing the unavailability of American made iron, steel, manufactured products, or construction materials.
2. Unreasonable Cost Waivers – Waivers reflecting that the overall cost of the infrastructure project with domestic iron, steel, manufactured products, or construction materials exceeds by more than 25 percent the overall cost of the project with foreign iron, steel, manufactured products, or construction materials.
3. Public Interest Waivers, which include:
 - i. de minimis standard waivers that exempt up to 5% of project costs up to the Simplified Acquisition Threshold when this would advance the public interest;
 - ii. small grants waivers for grants below the Simplified Acquisition Threshold when this would advance the public interest;
 - iii. adjustment period waivers such as brief, time limited waivers to allow recipients to transition to new rules and processes when this would advance the public interest;
 - iv. international trade obligations waivers when a recipient has assumed procurement obligations pursuant to the Government Procurement Agreement or any other trade agreement, and waivers to ensure compliance with such obligations may be in the public interest; and
 - v. general applicability waivers that are issued under limited conditions, e.g., product-specific waivers for which there are known domestic sourcing challenges.
4. Exigent Circumstances Waivers: In limited situations where there is an urgent need in an unforeseen and exigent circumstance, the COPS Office may waive the BABAA sourcing requirements without subjecting such waiver to public comments and the Office of Management and Budget's Made in America Office (MIAO) review.

Recipients do not need to obtain a waiver of the BABAA sourcing requirements from the COPS Office if they will use only American produced iron, steel, manufactured products, and construction materials for the project.

If a recipient determines a waiver is necessary, an application for a waiver should be submitted as soon as possible and provide detailed information to expedite the COPS Office's review. Recipients agree not to obligate, expend or draw down funds for infrastructure projects or activities unless they comply with the BABAA sourcing requirements or request and obtain a waiver of the requirements from the COPS Office.


