Subject: Recommendation for Approval to Establish a Prequalification Pool for Work Gloves

<u>Summary</u>

This pool will allow for the purchase of various types of work gloves for employees of multiple County departments for protection during the performance of their duties, as required by County established safety procedures and the Occupational Safety & Health Administration. Gloves purchased may include cotton, leather, cut resistant, and latex, and are used for multiple tasks, including to maintain the hygienic conditions at correctional and other facilities, to support medical care for residents and visitors, to sustain safety protections from hazardous chemicals, waste, and to prevent injuries for County employees.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the establishment of a prequalification pool, *EVN0003800*, *Work Gloves* for multiple County departments with an allocation of \$10,435,000 for a five-year term. The establishment of a pool is recommended to ensure that departments have access to a wide range of work gloves to address the varying needs of their personnel. A pool will allow for competition based on the scope, type, and quantities of work gloves required for routine and specific needs.

This pool will replace prequalification pool *5966-0/23*, established by the Board on November 19, 2013, through Resolution No. R-943-13 for a ten-year term. The pool was subsequently modified under delegated authority, and by the Board via Resolution Nos. R-31-18 and R-412-22. The current pool has 29 vendors, of which 13 are local, including six certified Small Business Enterprise (SBE) firms. There are 22 vendors being recommended for inclusion in the new pool, of which 13 are local, including ten SBEs. The pool will remain open to allow additional vendors to be added during the term of the pool.

To track pool expenditures by vendor, bidding under this and other prequalification pools are being conducted and monitored in a single platform, INFORMS, which allows staff to provide data reports to the Board, as requested.

Background

A Request to Qualify was issued on December 28, 2023. On the closing date of January 17, 2024, the County received 26 submittals, including 16 from local firms. Upon advertisement of the solicitation, a total of 44 vendors were notified and invited in INFORMS. Additional outreach efforts included contacting vendors identified through market research as well as notifying incumbent vendors.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The fiscal impact for the five-year term is \$10,435,000. The current pool is valued at \$14,068,315 for a ten-year and six-month term and expires on May 31, 2024. The annualized allocation under the replacement pool is higher than the current pool to account for the higher pricing due to prevailing market conditions and anticipated usage throughout the term of the pool.

^{*}The resultant contracts will contain termination for convenience provisions, and assignment clauses, which can be exercised if the commodities and/or services in this item are affected by the establishment of the constitutional offices.

Track Record/Monitor

Christopher Grant-Henriques of the Strategic Procurement Department (SPD) is the Procurement Contracting Manager.

Delegated Authority

Upon approval of this item, a pool of prequalified vendors will be established to participate in spot market competitions. The County Mayor or the County Mayor's designee will have the authority to solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board. The County Mayor or the County Mayor's designee will also have the authority to (a) exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38 and (b) add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis. Any contract under the pre-qualification pool exceeding \$5,000,000 is subject to ratification by the Board.

Vendors Prequalified for Pool

Twenty-two vendors are being recommended for inclusion in the pool as set forth in the table below. Pursuant to Resolution No. R-477-18, fewer than 75 percent of vendors recommended are local due to the reduced number of local businesses submitting qualifications. Additional outreach will be conducted to identify local vendors who may be eligible and interested in participating in the pool upon approval.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with SPD's Procurement Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues through various vendor responsibility lists and a keyword internet search. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to vendor responsibility.

Pursuant to Resolution No. R-140-15, prior to re-procurement, a full review of the scope of services was conducted to ensure the replacement pool reflects the County's current needs. The review included conducting market research, posting a draft solicitation for industry comment, and holding meetings and drafting sessions with user departments. The Scope of Services was modified to include provisions to source products from local manufacturers and eco-friendly considerations.

Applicable Ordinances and Contract Measures

- The two percent User Access Program applies where permitted by funding source.
- SBE measures will be determined prior to advertising each spot market competition where permitted by funding source. Local Preference will be applied at the time of spot market competition where permitted by funding source.
- The Living Wage Ordinance does not apply.

ESTABLISHMENT RESOLUTION AUTHORIZING OF **PREQUALIFICATION** POOL NO. EVN0003800 MULTIPLE COUNTY DEPARTMENTS FOR A FIVE-YEAR TERM IN A TOTAL AMOUNT UP TO \$10,435,000.00 FOR THE PURCHASE OF WORK GLOVES; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY DESIGNEE TO SOLICIT PRICING, AWARD CONTRACTS, EXERCISE ALL PROVISIONS OF THE SOLICITATION **DOCUMENTS** AND ANY RESULTING CONTRACTS PURSUANT TO SECTION 2-8.1 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA AND IMPLEMENTING ORDER 3-38, AND ADD VENDORS TO THE POOL AT ANY TIME, SUBJECT TO RATIFICATION BY THE BOARD ON A BI-ANNUAL BASIS: PROVIDED THAT ANY CONTRACT AWARD UNDER THE POOL EXCEEDING \$5,000,000.00 IS RATIFIED BY THE BOARD

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW. THEREFORE, BE IT RESOLVED \mathbf{BY} THE **BOARD** OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the establishment of Prequalification Pool No. EVN0003800 for multiple County departments for a five-year term in a total amount up to \$10,435,000.00 for the purchase of work gloves; and authorizes the County Mayor or County Mayor's designee to (a) solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board, (b) exercise all provisions of the solicitation documents and any resulting contracts pursuant to section 2-8.1 of the Code of Miami-Dade County, Florida and Implementing Order 3-38, and (c) add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis; provided that any contract award under the pool exceeding \$5,000,000.00 is ratified by the Board.
