Assistant County Attorney David Murray announced pursuant to the Board of County Commissioners (BCC) Chairman Oliver G. Gilbert, III memorandum dated January 8, 2024, entitled, "Requested Changes to the Community Health Committee (CHC) agenda", Agenda Items 1G1 Supplement, 1G1 Sub Supplement, 1G1 Sub Supplement No. 2 were added to today's (1/8) agenda, and noted there was a scrivener's error on Agenda Item 2A.

Report: Assistant County Attorney David Murray read the title of the foregoing proposed ordinance into the record.

Chairwoman Steinberg relinquished the chair to Vice Chairman McGhee.

Vice Chairman McGhee opened the public hearing. Seeing no one appearing wishing to speak, the public hearing was closed.

Senator Garcia reviewed the intent of the foregoing proposed ordinance and the changes included in the substitute version. He explained the legislation would create the Behavioral Health Advisory Board (BHAB) to assist individuals and families impacted by mental/behavioral disorders. Senator Garcia explained the BHAB would provide recommendations to the Board of County Commissioners (Board) on ways to address mental health and substance abuse in Miami-Dade County and noted the new mental health facility was a way for agencies to collaborate and not duplicate efforts.

Senator Garcia emphasized that he wanted Miami-Dade County to be a model for mental health treatment, and commented on the importance of providing professional and humane care to all parties involved. He further clarified that the substitute version would be further amended to include the Public Defender or his or her designee, the Director of the Miami-Dade Community Action and Human Services Department or his or her designee; and to increase the membership under 2-427(a)(14) and (15) to two (2) instead of one (1).

Commissioner Gonzalez requested to be added as a co-sponsor, and thanked Senator Garcia for championing the efforts to bring forth comprehensive legislation.

recommendation with committee amendments following public hearing Mover: García Seconder: McGhee Vote: 4-0 Absent,OCB: Cabrera In response to Chairwoman Steinberg's request for clarification regarding the quorum requirement, Assistant County Attorney Shanika Graves explained the BHAB would be comprised of 21 members with a majority of members present needed for quorum. She proceeded to read into the record the quorum requirements outlined on Page MDC010, Section 2-428(e).

Chairman Steinberg commented on the size of the BHAB and how quorum requirements sometimes impede the functions of such boards.

Senator Garcia explained the changes to the membership numbers were made to ensure adequate family representation.

The foregoing proposed ordinance was amended to revise Section 2-427(a) to increase the number of voting members of the Behavioral Health Advisory Board from 17 to 21, with the additional members to include the Public Defender or his or her designee, the Director of the Miami-Dade Community Action and Human Services Department or his or her designee; and to increase the membership under 2-427(a)(14) and (15) to two (2) instead of one (1); and to make conforming changes throughout the document.

There being no further questions or concerns, the Committee proceeded to vote on the foregoing ordinance, as amended.
