**WHEREAS**, music is important to the arts as it inspires creativity, expression, and emotional resonance; and

**WHEREAS**, Miami-Dade County has been fertile ground for musical innovation, has long been a cultural epicenter of diverse artistic expression, and is home to many musicians who have made significant contributions to the global music scene; and

**WHEREAS**, Miami-Dade County born artists have been at the forefront of shaping contemporary music, influencing both the sounds and the culture, and achieving remarkable success on both the national and international charts; and

**WHEREAS**, Miami-Dade born or based artists, such as but not limited to, Betty Wright, Trick Daddy, Trina, Flo Rida, Luther (Uncle Luke) Campbell, JT Money, Rick Ross, Pitbull, DJ Khalid, Pretty Ricky, and City Girls, have used their platforms to uplift their communities, mentor aspiring artists, and represent Miami-Dade County on a global stage; and

**WHEREAS**, these and other locally born or based artists have achieved significant chart successes, earning placements on the Billboard Hot 100, Billboard 200, and R&B/Hip-Hop charts, and other prestigious music rankings, and received awards and accolades from respected institutions in the music industry; and

**WHEREAS**, not only have these artists achieved chart success, but they have contributed to the shaping of music, history, fashion, dance, and social movements through their work; and

**WHEREAS**, these artists have not only contributed to the cultural identity of Miami-Dade County but have also stimulated the local economy through concerts, business ventures, and philanthropic efforts; and

**WHEREAS**, Miami-Dade County takes great pride in fostering a supportive environment for artists of all genres and continues to celebrate the success and legacy of these musicians; and

**WHEREAS**, co-designating streets in honor of some of the iconic songs by artists born and raised in this County, or who have otherwise come to call this County home, will serve as a

lasting tribute to the artists' contributions and to revitalize the 18th Avenue Corridor into a musical tourist attraction and reinforce the idea that residents do not have to leave their community to experience a vibrant and thriving environment; and

**WHEREAS**, the newly named streets will serve as a cultural landmark, attracting visitors, creating unique photo opportunities, and increasing local recognition for both the artists and the community; and

**WHEREAS**, through the adoption of this resolution, the Board wishes to instill a sense of pride and ownership among residents, ensuring that Liberty City is recognized as a hub of musical history and artistic influence; and

**WHEREAS**, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding proposed naming, renaming or co-designation of Miami-Dade County roads, facilities or property shall be sponsored by the district commissioner where the road, facility or property is located and shall be considered at a public hearing; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA,** that this Board:

**Section 1.** Having considered this matter at a public hearing, codesignates the following roads:

- That portion of NW 62nd Terrace between NW 18th Avenue and NW 19th Avenue as “What’s My Name Street”.

- That portion of NW 63rd Street between NW 18th Avenue and NW 19th Avenue as “City Girls Street”.
- That portion of NW 64th Street between NW 18th Avenue and NW 19th Avenue as “Soul Ties Street”.
- That portion of NW 65th Street between NW 18th Avenue and NW 19th Avenue as “Post & Delete Street”.
- That portion of NW 66th Street between NW 18th Avenue and NW 19th Avenue as “Chase Dis Money Street”.
- That portion of NW 67th Street between NW 18th Avenue and NW 19th Avenue as “Born N Raised Street”.
- That portion of NW 68th Street between NW 18th Avenue and NW 19th Avenue as “Big Money Baller Street”.
- That portion of NW 68th Terrace between NW 18th Avenue and NW 19th Avenue as “We the Best Terrace”.
- That portion of NW 69th Street between NW 18th Avenue and NW 19th Avenue as “Still Da Baddest Street”.
- That portion of NW 69th Terrace between NW 18th Avenue and NW 19th Avenue as “Trick Love the Kids Street”.
- That portion of NW 70th Street between NW 18th Avenue and NW 19th Avenue as “It’s Your Birthday Street”.
- That portion of NW 71st Street between NW 18th Avenue and NW 19th Avenue as “Bad Boys Bad Boys Street”.

- That portion of NW 62nd Terrace between NW 18th Avenue and the jurisdictional boundary of the City of Miami, as “Welcome To The MIA Terrace”.
- That portion of NW 63rd Street between NW 18th Avenue and the jurisdictional boundary of the City of Miami, as “I Luv My Dawgs Street”.
- That portion of NW 64th Street between NW 18th Avenue and the jurisdictional boundary of the City of Miami, as “I Deserve It All Street”.
- That portion of NW 65th Street between NW 18th Avenue and the jurisdictional boundary of the City of Miami, as “Closer to My Dreams Street”.
- That portion of NW 66th Street between 18th Avenue and the jurisdictional boundary of the City of Miami, as “Tunnel Vision Street”.

- That portion of NW 69th Terrace between NW 18th Avenue and the jurisdictional boundary of the City of Miami, as “Peace In Da Hood Street”.
- That portion of NW 70th Street between NW 18th Avenue and the jurisdictional boundary of the City of Miami, as “Run Da Yard Street”.
- That portion of NW 71st Street between NW 17th Avenue NW 18th Avenue, as “No Pain, No Gain Street”.
- That portion of NW 18th Avenue between NW 62nd Terrace and NW 71st Street as “Memory Lane Avenue”.
