RESOLUTION DESIGNATING RASHA CAMEAU AS CHAIRWOMAN AND JEFFY V. MONDESIR AS VICE CHAIRMAN OF THE N.W. 7TH AVENUE CORRIDOR COMMUNITY REDEVELOPMENT AGENCY IN ACCORDANCE WITH SECTION 163.356, FLORIDA STATUTES, AND SECTION 2-1889 OF THE CODE OF MIAMIDADE COUNTY, FLORIDA

**WHEREAS**, this Board created the NW 7<sup>th</sup> Avenue Corridor Community Redevelopment Agency ("Agency") upon the adoption of Ordinance No. 06-18 and appointed an initial Agency board of commissioners pursuant to section 163.356, Florida Statutes; and

**WHEREAS**, on September 4, 2024, this Board adopted Resolution No. R-783-24, which appointed Rasha Cameau as a commissioner to the Agency; and

**WHEREAS**, this Board desires to designate Rasha Cameau as chairwoman of the Agency in accordance with section 163.356, Florida Statutes, and section 2-1889 of the Code; and

**WHEREAS**, on November 15, 2022, this Board adopted Resolution No. R-1134-22, which, among other things, appointed Jeffy V. Mondesir as a commissioner and designated him as vice chairman of the Agency; and

**WHEREAS**, this Board desires to designate Jeffy V. Mondesir again as vice chairman of the Agency, in accordance with section 163.356, Florida Statutes, and section 2-1889 of the Code,

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

<u>Section 1</u>. The foregoing recitals are incorporated in this resolution and are approved.
