Executive Summary

This memorandum seeks approval from the Board of County Commissioners (the Board) to award Contract No. S-20024, West Little River Neighborhood Proposed Pump Station and Sanitary Sewer System (the Contract), to the lowest responsive and responsible bidder, Magnum Construction Management, LLC (MCM). The project will extend sewer service to the West Little River area (the Project), pursuant to the County's Connect to Protect (C2P) Program, and involves the installation of approximately 26,100 LF of sanitary sewer mains and the construction of a new pump station that will service the West Little River neighborhood. Notably, the project will be funded in part by the Florida Resilient Grant Program, secured through the department's ongoing commitment to enhancing resiliency and pursuing sustainable funding opportunities. The fiscal impact to the County will be \$20,172,150.00.

Recommendation

It is recommended that the Board award Contract S-20024 to MCM for a total compensation amount of \$20,172,150.00, with a total Contract period of 561 calendar days and a time contingency allowance of 56 calendar days.

Scope

The Project will be performed in the West Little River area, which is bounded by approximately the Little River on the north, NW 79th Street on the south, I-95 on the west, and N. Miami Avenue on the east, and is located in District 2, which is represented by Commissioner Marleine Bastien.

Delegated Authority

Upon Board approval of the Contract, the County Mayor or County Mayor's designee may exercise all provisions, including the termination provisions, within the Contract.

In addition, the County Mayor or County Mayor's designee will manage this Contract pursuant to section 2-8.2.12 of the Code of Miami-Dade County, Florida (the WASD Acceleration Ordinance), which delegates authority to the County Mayor or County Mayor's designee to, among other things, negotiate and settle claims and execute change orders that do not exceed ten percent (10%) of the base contract amount, subject to ratification by the Board.

Fiscal Impact/Funding Source

The fiscal impact to the County is \$20,172,150.00, which WASD has determined is a fair and reasonable amount for the Project's defined scope of work. The Project is in the Adopted Budget and Multi-Year Capital Plan.

- Funding will be provided from Program #9653261, Wastewater Treatment Plants - Replace

Improvements, Page 95, in the FY2023-24 Adopted Budget and Multi-Year Capital Plan, Volume 3.

- The funding sources are Wastewater Special Construction, Wastewater Renewal Fund, and BBC GOB Financing. Funding from the Florida Resilient Grant Program may be available and will be utilized if possible.
- The life expectancy of the work is 50 years.
- Operations Cost Impact / Funding: \$500,000 per year. The funding source for the operating impact is WASD Operating Revenues.
- Maintenance Cost Impact / Funding: \$60,000 per year. The funding source for the maintenance impact is WASD Operating Revenues.
- The project does include GOB funding.
- The IG Fee is included.

Vendor Selection & Track Record

On August 27, 2024, WASD received and opened the following nine (9) bids in response to the June 27, 2024 advertisement for an open competitive solicitation for the Contract.

The following due diligence was performed to determine that MCM is the lowest responsive and responsible bidder:

- Because contract measures were assigned, the three (3) lowest bids were forwarded to Internal Services Department's (ISD) Division of Small Business Development (SBD) for a Compliance Review. On September 10, 2024, SBD issued the results of its compliance review. All three firms were determined to be in compliance with the Implementing Order for the Small Business Enterprise (SBE/G&S) program for goods and services. The Project Worksheet and the SBD Compliance Review letter are attached to this memo as Exhibits A and B, respectively.
- There were two (2) Engineers of Record for this Project. The Engineer of Record for the pipeline portion of this Contract, CHA Consulting, Inc. (the EOR1), reviewed the bid submission and, on October 4, 2024, the EOR1 determined that the low bid was acceptable as submitted and that MCM satisfied the requirements of the solicitation for the pipeline. The Engineer of Record for the pump station portion of this Contract, Parsons (the EOR2), reviewed the bid submission and, on October 11, 2024, determined that the low bid was acceptable as submitted and that MCM satisfied the requirements of the solicitation for the pump station. The letters from EOR1 and EOR2 are attached as Exhibits C and D, respectively.

- Pursuant to Resolution No. R-187-12, WASD performed a review of the vendor information in the Business Management Workforce System (BMWS). WASD discovered no adverse information.
- According to the contract history downloaded from the BMWS on October 17, 2024, over the past three years, MCM has been awarded three (3) contracts from the County in the total amount of \$42,047,821.
- MCM has 31 evaluations in the ISD Capital Improvement Information System (CIIS), with a rating of 3.6 out of a possible 4.0 maximum.
- After the bids were opened, WASD discovered that funding from the Florida Resilient Grant Program could be used for this Project. This source of funding required a modification of the Special Provisions in order to add Special Provision (SP) 57 to address grant funding. After discussing this with the bidder, MCM agreed to incorporate SP 57 into the Contract without condition and agreed that any price escalation claim relative to SP 57 would be limited by the terms of SP 32, Escalation of Bid Items. SP 32 was a part of the Project bid set.

Considering the input of ISD and the EORs, WASD has concluded that the apparent lowest bidder, MCM, is both responsive and responsible. The total bid of \$20,172,150.00 is 12.1% above the Engineer's estimate of \$17,989,449.85; the bidder has a 3.6 rating in CIIS; and there are no protests. Therefore, it is recommended that Contract S-20024 be awarded to MCM for a total compensation amount of \$20,172,150.00, with a total Contract period of 561 days. The proposed Contract, signed by MCM, is attached to this memo as Exhibit E.

WASD Contract Monitor

WASD Deputy Director, Planning Regulatory Compliance and Capital Infrastructure, Marisela Aranguiz-Cueto, P.E., will oversee the implementation of the Contract.

Background

This Project advances the County's commitment towards environmental protection, in particular, protection of water quality in Biscayne Bay by providing sanitary sewer service to areas that are both vulnerable to sea-level rise and currently served by septic systems.

Parsons received the bid package from the lowest bidder for the project via e-Builder on September 3, 2024. Parsons reviewed and analyzed the Bid Tally for the lowest bidder and reviewed the lowest bidder qualifications.

On September 11, 2024, Parsons recommended that additional qualifications be submitted by the lowest bidder to demonstrate additional experience, prior to recommending approval of the lowest bidder.

On September 19, 2024, Miami-Dade Water and Sewer Department held a responsibility review meeting and determined that the lowest bidder has the necessary resources to proceed with the project and requested that additional experience information be submitted.

Parsons received additional project experience information on September 25, 2024. This information has been reviewed and considered.

Parsons reviewed the additional project experience for the lowest bidder. The Project Team Members have the qualifications for this type of construction work. However, only one of the three additional projects presented comply with the requirements outlined in the Bid Documents. However, based on the Project Team Members, staffing plan and the determination by MDWASD during the responsibility review meeting that the lowest bidder has the necessary resources to proceed with the project, Parsons concludes that the lowest bidder can move forward with the project and MDWASD can proceed with awarding the Contract.

THIS CONTRACT, made and entered into on the ____ day of _____, 20____, by and between Miami-Dade County, Florida, acting by and through the Office of the Mayor, party of the first part (hereinafter sometimes called the "County"), and Magnum Construction Management, LLC, party of the second part (hereinafter sometimes called "Contractor");

WITNESSETH

That the parties hereto, for and in consideration of the covenants and agreements hereinafter set forth, mutually agree as follows, to wit:

1. That the Contractor shall furnish all labor, materials and equipment and perform all work in the manner and form provided by the Contract Documents covering the Project of the County known and identified as

WEST LITTLE RIVER NEIGHBORHOOD PROPOSED PUMP STATION AND SANITARY SEWER SYSTEM, CONTRACT No. S-20024

for the aggregate amount reflected by the Proposal, said aggregate amount being of Twenty Million One Hundred Seventy Two Thousand One Hundred Fifty Dollars and No Cents (U.S. Dollars) \$20,172,150.00.

2. That the Contractor shall begin the work to be performed under this Contract on a day to be specified in a written order issued by the Engineer and shall fully complete all work hereunder within the time or times stated in the Proposal.

3. That the County shall pay to the Contractor for the faithful performance of this Contract, in lawful money of the United States, and subject to additions and deductions as provided in the Contract Documents, the total amount of the Proposal as set forth above at the times and in a manner stated in the General Contract Conditions of the Contract Documents.

4. It is further mutually agreed that if at any time after the execution of this Contract, Surety Performance and Payment Bond, the County shall deem the surety upon such bonds to be unsatisfactory, or if for any reason such bond shall become inadequate to cover the performance of the work, the Contractor shall at its own expense, within five (5) days after the receipt of notice from the County to do so, furnish an additional bond or bonds in such form and amount and with such surety or sureties as shall be satisfactory to the County. In such event, no further payment to the Contractor shall be deemed to be due under this Contract until such new or additional security shall have been furnished in a manner and form satisfactory to the County.

5. The "Contract Documents" are hereby defined as the Advertisement for Bids, Questionnaire, Instruction to Bidders, Proposal, Certified Resolution for Proposal and Bid Form, Bid Bond, all forms submitted pre and post award, including, without limitation, Miami-Dade County Vendor Affidavits Form, Sworn Statement – Public Entity Crimes, Clearinghouse Affidavit and Job Order Request form, this Contract, Certified Resolution for Contract and Performance and Payment Bond, Performance and Payment Bond, Standard Construction General Contract Conditions, revised August 1, 2023, the Technical Specifications, Plans and Drawings designated in the specifications, all Technical Appendices, all Addenda, Water & Sewer Department Special Provisions, Change Orders to the Contract, Notice to Proceed, Referenced Codes and Standards, Warranties and Guarantees, all related correspondence, field notes, logs, and other documents.

CONTRACT

The Standard Construction General Contract Conditions of said Contract Documents are incorporated herein by reference and made a part hereof as though fully set forth herein. The Contract Documents are complementary, so that a recital in one is tantamount to a recital in all, and the Contractor specifically acknowledges that it has read and understands all of said Contract Documents.

6. After the bids were opened, WASD discovered that funding from the Resilient Florida Grant Program could be used for this project. To ensure compliance with Grant requirements, it was necessary to modify the Special Provisions, specifically to add Special Provision (SP) 57, Requirements for Projects with Funding from the FDEP Resilient Florida Grant Program. Contractor agrees to incorporate SP 57 into the contract terms without condition and agrees that any price escalation claim relative to SP 57 is limited by the terms of SP 32, Escalation of Bid Items.

7. The various indemnities of the Contractor contained in the Contract Documents indemnifying the County from liability for damages to persons or property caused by acts, omissions, or defaults in the performance of the Contract Documents shall have a monetary limitation of the larger of the following: \$1,000,000.00, or the entire amount of the Contract.

8. The County retains the right to audit any and all information regarding this Contract as described in the Standard Construction General Contract Conditions, Article 12 G (Miscellaneous Provisions – Audit Rights)

9. Notwithstanding and prevailing over any other provision of the Contract Documents to the contrary, the County Mayor or his designee, may exercise the provisions of Section 2-8.2.12 (4)(d) and (e) of the Code of Miami-Dade County. Any change orders or amendments shall not exceed 10 percent of the base contract price in cumulative percentage amount; provided however, that the foregoing limitation shall not apply to any change order or amendment related to emergency actions impacting remediation, public safety, health requirements or recovery from natural disaster and the foregoing change orders and amendments shall require ratification by the Board; provided further that the County Mayor or his designee may reduce in any amount the scope and compensation payable under this Contract and grant compensable and non-compensable time extensions thereunder. Pursuant to Section 2-8.2.12 (5), the Mayor or the Mayor's designee's award and execution of this Contract is subject to ratification by the Board of County Commissioners. If the Mayor or the Mayor's designee's action is not ratified, and such legislative action becomes final, this Contract shall be deemed terminated without further notice. In such event, the Contractor shall not be entitled to recovery of any lost profits or other consequential or indirect damages. However, the Contractor is eligible for payment for any work done prior to failure of the ratification, in accordance with General Contract Conditions Article on Termination for Convenience.

10. "Contract Execution Date" means the date of the last signature on this contract.

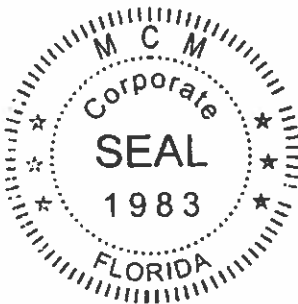

WHEREAS, this Board desires to accomplish the purpose outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby awards Contract No. S-20024 (the “Contract”) for the West Little River Neighborhood Proposed Pump Station and Sanitary Sewer System, in substantially the form attached to the accompanying memorandum as Exhibit E, to Magnum Construction Management, LLC for a total contract term of 561 calendar days plus a 56-calendar day contingency period and a total contract amount of

\$20,172,150.00, funded in part by Building Better Communities General Obligation Bonds Program Project No. 17 – “Countywide Water And Sewer System Enhancements”, and grant funds from the Florida Resilient Grant Program, if available. The Board also authorizes the County Mayor or County Mayor’s designee: (1) to use the Miami-Dade Water and Sewer Department’s Consent Decree and Capital Improvement Programs Acceleration Ordinance, section 2-8.2.12 of the Code of Miami-Dade County, Florida, to manage the Contract; (2) to execute the Contract for and on behalf of the County; and (3) to exercise the termination and other provisions contained within the Contract.
