RESOLUTION NO. _____

RESOLUTION CODESIGNATING, BY A THREE-FIFTHS VOTE OF BOARD MEMBERS PRESENT, THAT PORTION OF NORTHWEST 131ST STREET BETWEEN NORTH MIAMI AVENUE AND NORTHWEST 2ND AVENUE AS “COUNCILMAN JACQUES DESPINOSSE STREET;” AND APPROVING THE CITY OF NORTH MIAMI CODESIGNATIONS OF THAT PORTION OF NORTHEAST 131ST STREET BETWEEN NORTHEAST 2ND AVENUE AND NORTH MIAMI AVENUE, AND THAT PORTION OF NORTHWEST 131ST STREET BETWEEN NORTHWEST 2ND AVENUE AND NORTHWEST 13TH AVENUE, AS “COUNCILMAN JACQUES DESPINOSSE STREET”

WHEREAS, Jacques Despinosse was born in Haiti and immigrated to New York City in 1968, where he embraced entrepreneurship by opening a variety store in Brooklyn, selling African and Haitian goods and music; and

WHEREAS, in 1977, he relocated with his family to Miami, Florida, settling in Little Haiti and later becoming active in American civic and political life; and

WHEREAS, recognizing the importance of civic engagement, Jacques founded the Haitian American Democratic Club of Greater Miami in 1985 and became deeply involved in local, state, and national politics, serving as a delegate to six Democratic National Conventions and advocating for Haitian interests in Washington, D.C.; and

WHEREAS, Jacques was honored by President Bill Clinton with the opportunity to serve as an observer of the electoral process in Haiti on two occasions, further solidifying his reputation as a trusted voice for the Haitian-American community; and

WHEREAS, understanding the power of the vote, Jacques tirelessly encouraged Haitian immigrants to pursue U.S. citizenship to gain political representation and influence, culminating in his own political career with his 1994 campaign for State House District 104 and subsequent elections to the City of North Miami City Council in 2001 and 2005; and

WHEREAS, even after leaving public office, Jacques Despinosse has remained an active figure in the political landscape through his long-running radio program, *Radio Citizen*, and ongoing community advocacy with the local Democratic Party; and

WHEREAS, throughout the years, Jacques was always supported by his family, including his late wife Ruth, late mother Amarante, his four children, and one grandchild; and

WHEREAS, it is anticipated that on May 27, 2025, the Mayor and City Council of the City of North Miami (the “City”) will adopt a Resolution codesignating that portion of Northeast 131st Street between Northeast 2nd Avenue and North Miami Avenue, and that portion of Northwest 131st Street between Northwest 2nd Avenue and Northwest 13th Avenue as “Councilman Jacques Despinosse Street” to acknowledge the contributions of Jacques A. Despinosse to the City of North Miami; and

WHEREAS, the City would like for the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, that portion of Northwest 131st Street between North Miami Avenue and Northwest 2nd Avenue is a County-maintained road located in Unincorporated Miami-Dade County and within County Commission District 2; and

WHEREAS, that portion of Northeast 131st Street between Northeast 2nd Avenue and North Miami Avenue, and that portion of Northwest 131st Street between Northwest 2nd Avenue and Northwest 13th Avenue, are City-maintained roads located in the City and within County Commission District 2; and

WHEREAS, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding proposed naming, renaming, or codesignation of Miami-Dade County roads, facilities, or property shall be sponsored by the district commissioner where the road, facility, or property is located and shall be considered at a public hearing; and

WHEREAS, Rule 9.02 also provides that the Board may, by a three-fifths vote of the Board members present, name a County road, facility, or property after a living individual who "has made a direct, significant lifetime contribution to this community"; and

WHEREAS, Jacques Despinosse has made direct, significant lifetime contributions to Miami-Dade County; and

WHEREAS, this Board would like to honor Jacques Despinosse and his contributions to the community by (1) codesignating that portion of Northwest 131st Street between North Miami Avenue and Northwest 2nd Avenue as "Councilman Jacques Despinosse Street;" and (2) approving the City's codesignations of that portion of Northeast 131st Street between Northeast 2nd Avenue and North Miami Avenue, and that portion of Northwest 131st Street between Northwest 2nd Avenue and Northwest 13th Avenue, as "Councilman Jacques Despinosse Street,"

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Incorporates the foregoing recitals into this resolution and finds that Jacques Despinosse has made direct, significant lifetime contributions to this community pursuant to Rule 9.02(d).

Section 2. Having considered this matter at a public hearing and by a three-fifths vote of Board members present, codesignates that portion of Northwest 131st Street between North Miami Avenue and Northwest 2nd Avenue as “Councilman Jacques Despinosse Street”.

Section 3. Approves the City of North Miami’s codesignations of that portion of Northeast 131st Street between Northeast 2nd Avenue and North Miami Avenue, and that portion of Northwest 131st Street between Northwest 2nd Avenue and Northwest 13th Avenue, as “Councilman Jacques Despinosse Street”.

Section 4. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor and City Council of the City of North Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Sheriff’s Office, the City of North Miami Police Department, and the Miami-Dade County Fire-Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Marleine Bastien. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
