Subject: Revised - Community Based Organization (CBO) FY 2023-24 Report Card

Executive Summary

This report is provided pursuant to Implementing Order (IO) 3-15, Uniform Minimum Standards for Application, Contracting, Assessment, Monitoring, Organizational Review, and Performance Review of Community-Based Organizations (CBO) Monitored by the Office of Management and Budget (OMB). CBOs managed by OMB are funded annually as part of the budget process and upon approval of the applicable budget ordinance by the Board of County Commissioners (Board).

Pursuant to IO 3-15, a Report Card detailing findings from annual Performance Reviews of the CBOs shall be presented to the Board on an annual basis. This report includes the CBO Report Card based on FY 2023-24 Performance Reviews.

Background

This report includes report card ratings for the CBOs approved as part of the annual budget process in FY 2023-2024, Ordinance No. 23-76 (Appendix F of the budget ordinance). Through the CBO agreements, Miami-Dade County (County) provides funding for services in twelve priority areas including: Anti-Violence; Basic Needs; Children & Adults with Disabilities; Children, Youth & Families; Criminal Justice; Elder Needs; Food Programs; Health; Immigrants/New Entrants; Special Needs; Workforce Development; and Other.

Pursuant to IO 3-15, OMB conducted Performance Reviews of the CBOs it manages to evaluate: 1) deliverables and program achievement, and 2) administration and contract compliance. These Performance Reviews serve as the basis for the report card ratings.

The CBO Report Card rates organizations using a green, yellow, and red stoplight scale, as delineated in IO 3-15, as amended by the Board through Resolution No. R-453-24:

- Green five (5) or fewer instances of non-compliance
- Yellow more than five (5) instances of non-compliance and/or receiving a suspension that has since been resolved
- Red any number of instances of non-compliance that merit contract or payment suspension that are not resolved

An instance of non-compliance is failure to comply with the terms and conditions stipulated in the CBO agreement or lack of adequate documentation to prove compliance.

FY 2023-24 CBO Report Card

CBOs managed by OMB in FY 2023-24 are reflected in the CBO Report Card (Attachment 1) with their respective report card rating.

Below is a summary of the FY 2023-24 CBO Report Card ratings:

• 116 CBOs received a general fund contract. Of those:

- 101 organizations received a green rating.
- 13 organizations received a yellow rating. However, 10 of the 13 yellow rated organizations were previously rated red and were changed to yellow upon acceptance of a Corrective Action Plan.
- o 2 organizations received a red rating. The agency contracts were terminated and the remaining unspent funds at the time of termination were returned to the general fund.
