Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for JGK Realty Investments, LLC is bounded on the north by NW 60 Street, on the east by NW 77 Court, on the south approximately 500 feet north of NW 58 Street, and on the west approximately 220 feet east of NW 79 Avenue.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:
