Section 2-1 Rule 9.02(f) of the Code requires the Office of the Commission Auditor (OCA) to conduct background research on any person, organization, place, or thing that is the subject of a naming, renaming, or codesignation item, or an item approving the codesignation of state or municipal roads and prepare a report detailing the findings of said research before the Commission meeting during which the item is scheduled to be considered.

**Commission Auditor's Conclusion:**

OCA completed the required background research on "Jacques Despinosse" and noted no adverse findings. OCA has determined that there are no prior Board of County Commissioners (BCC) codesignations for "Jacques Despinosse." Also, as required by rule 9.02(f)(1), OCA has verified that "Jacques Despinosse" is living. OCA provides this report as a Supplement to BCC Agenda File Item No. 250946.
