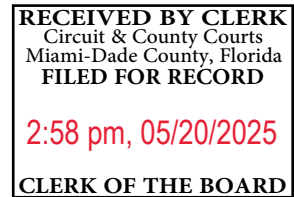

**Subject:** Mayoral Appointment – Director of the Parks, Recreation and Open Spaces Department

Pursuant to the authority vested in me under Section 2.02(C) of the Miami-Dade County Home Rule Charter, I hereby appoint Christina White to the position of Director of the Parks, Recreation and Open Spaces Department (PROS), effective June 2, 2025

Christina White has served Miami-Dade County since 2002, primarily working with the Elections Department – now an independent Constitutional Office. In 2015, Christina was appointed as Supervisor of Elections; in this role she oversaw the largest elections operation in the state of Florida and seventh largest in the nation. This includes administering up to 30 federal, state, and municipal elections annually, serving more than 1.5 million registered voters, processing 500,000 mail-in ballots, managing up to 33 early voting locations and 850 precincts on Election Day for countywide elections. Christina is an exceptional administrator with extensive experience in managing complex operations, identifying operational efficiencies, and implementing strategic planning initiatives. Since January 2025 she has served as the Chief Executive Officer in the Office of the Supervisor of Elections. A copy of her resume is attached for your reference.

I want to express my gratitude to Maria Nardi for serving as Parks Director since 2017. Prior to her work at Miami-Dade County, Ms. Nardi initiated Miami21; a rewrite of the City of Miami's zoning to transform the city into a walkable, pedestrian friendly community. Maria will be joining the Department of Housing and Community Development (HCD) as an Assistant Director, responsible for Land Planning, Development and Communications for the department. Maria's background includes over 18 years of experience in the private and public sector including urban design, architecture, and planning. She holds a baccalaureate degree in architecture from the University of Miami and a master's degree in landscape architecture from Harvard University.

Please join me in welcoming Christina to her new role while also thanking Maria for her continued service.
