Subject: Request for a Non-Competitive Designated Purchase for Additional Time and Expenditure Authority Under Contract Nos. RFP-00188A-D and RFP-00217 for Security Guard Services

Summary

This item is for additional time of four years and expenditure authority for the continued purchase of security guard services under four contracts for the Water and Sewer Department (WASD) and one contract for the People and Internal Operations Department (PIOD). This extension will allow for the maintenance of the current service rates that otherwise may be susceptible to economic volatility. By extending the agreements, the County will avoid exposure to potential rate increases driven by market instability and the current labor market. Furthermore, both departments are satisfied with the performance of the three awarded vendors, who were selected through a competitive solicitation process.

As the largest utility in the Southeastern United States, WASD represents not only a vital service provider but also a potential target for those who seek to disrupt essential services. Maintaining robust security guard services is therefore imperative to protecting our community, safeguarding staff and facilities, and ensuring the uninterrupted delivery of safe and reliable water and wastewater services. Continued investment in these security measures also strengthens the County's operational resilience, reinforces public trust, and upholds our responsibility to secure one of Miami-Dade County's most critical assets.

It is important to note, issuing a new competitive solicitation at this time could lead to unfavorable pricing outcomes. The original contracts were procured through a competitive process and continue to provide services that are essential for maintaining the safety and security of County personnel, facilities, and the public. Given the critical nature of these services and the need to ensure continuity and stability, it is in the County's best interest to approve a designated purchase pursuant to Section 2-8.1(b)(3) of the Miami-Dade County Code to maintain ongoing security operations without interruption.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve a non-competitive designated purchase pursuant to Section 2-8.1(b)(3) of the Miami-Dade County Code, by a two-thirds vote of the Board members present, under the below listed contracts to extend each agreement for an additional four years with expenditure authority. Extending the agreements with the current vendors will assist the County as it continues efforts to enhance efficiency and reduce costs for essential services in anticipation of future market uncertainties.

Contract Nos. RFP-00188A-D, Security Guard Services for Miami-Dade Water and Sewer Department, and RFP-00217, Security Guard and/or Screening Services, are included in this recommendation. The contracts support multiple departments and security needs across various risk levels. These services are critical for protecting County personnel, property, and the public, and require highly trained, experienced, alert, and dependable security guards.

The County's tier system classifies facilities and posts by risk level, ranging from Tier 1 to Tier 3. *Contract Nos. RFP-00188A-D, for the Water and Sewer Department (WASD), provide Tier 3-level security services, representing the highest level of security risk. WASD is requesting an allocation of \$72,000,000 over the four-year period. Contract No. RFP-00217, for the People and Internal Operations*

Department (PIOD), provides security guard services across all three tiers, offering coverage based on the specific risk level of each facility or post. PIOD is requesting an allocation of \$230,961,600 over the four-year period.

Background

These contracts were approved by the Board on September 1, 2017, through Resolution Nos. R-749-17 and R-750-17. All of the contracts were awarded for an initial three-year term, with the option to renew for two additional three-year periods.

Contract No. RFP-00188 for WASD was awarded to three vendors by service sector which represents a specific geographical location (A/B/C/D): 1) Universal Protection Services, LLC dba Allied Universal Security Services (Allied); 2) Centurion Feick Partnership (Centurion Feick); and 3) Security Alliance, LLC. *Contract No. RFP-00217* was awarded to Allied for all tiers. During the first renewal period, the contract was amended through a Designated Purchase approved through Resolution No. R-1166-22, which authorized an additional allocation to cover anticipated costs associated with the Living Wage Ordinance and Paid Sick Leave requirements. The second contract renewal period was approved through Resolution No. R-1006-23.

Scope

The impact of this item is countywide in nature.

Delegated Authority

The County Mayor or the County Mayor's designee will have the authority to execute all related Supplemental Agreements to the contracts and exercise all provisions contained therein.

Fiscal Impact/Funding Source

Contract No. RFP-00217 is scheduled to expire on August 31, 2026, and has an allocation of \$319,874,947. If this request is approved, the contract will be extended to August 31, 2030 and have a modified cumulative allocation of \$550,836,547. *Contract Nos. RFP-00188A-D* for WASD are scheduled to expire on August 31, 2026, and have a modified cumulative allocation of \$109,923,717. If this request is approved, the contracts will be extended to August 31, 2030 and have a modified cumulative allocation of \$181,923,717. This requested allocation authority takes into consideration historical patterns of usage related to the provision of security guard services.

Allied and Centurion Feick have agreed to maintain their existing rates for the duration of the extension, except for any adjustments required by Living Wage or Paid Sick Leave provisions. Security Alliance, LLC has offered a 0.005% discount on the existing rates for all hourly security guard positions, excluding the project manager and any vehicle-related rates. This discount will be applied to the rates effective October 1, 2025, following the Living Wage adjustment.

Contract No. RFP-00188, Security Guard Services for Miami-Dade Water & Sewer Department was reviewed for compliance with the Small Business Enterprise – Services (SBE-Services) measures, Living Wages, and Paid Sick Leave requirements. Resolution No. R-1001-15 (R-1001-15) requires County contracts with SBE measures meet at least 85 percent of the SBE goals applicable to the portion(s) of the contract work performed to date before a change order or contract amendment is considered for Board approval.

1. RFP-00188 Sector A: This sector was awarded with a 20% SBE-Services goal. The prime, Universal Protection Service, LLC dba Allied Universal, has requisitioned \$40,200,000 requiring \$6,834,000 be performed by the SBE-Services firm for compliance with R-1001-15. To date the SBE-Services firm has performed and been paid \$7,190,600 in compliance with R-1001-15.
2. RFP-00188 Sectors B & C: These sectors were awarded with an SBE-Services Set Aside measure. The prime, Centurion/Feick Partnership, was in compliance with the SBE-Services Set Aside measure through July 31, 2025 when their SBE-Services certification expired. Pursuant to the SBE-Services program requirements, SBEs must retain SBE certification while performing work designated for SBE firms.
3. RFP-00188 Sector D: This sector was awarded with a 20% SBE-Services goal. The prime, Security Alliance, LLC has requisitioned \$31,081,597 requiring \$5,283,871 be performed by the SBE-Services firms for compliance with R-1001-15. To date, the SBE-Services firms have performed and been paid \$6,620,603 in compliance with R-1001-15.

- a) The above total fixed hourly and annual rates are guaranteed, pursuant to Article 8, and include all costs necessary to provide security guard services, such as, wages and benefits paid to guards, cost of equipment, cost for supervision, overhead, all out-of-pocket expenses, such as travel, per diem, and miscellaneous costs and fees, as they will not be reimbursed by the County separately.
- b) The County may consider an adjustment to the price based upon an increase to the Living Wage amount (refer to Section 8 of the Contract).
- c) The above rates take into account the Living Wage increase for 2025 – 2026. Refer to Article 8 of the contract for information on Living Wage adjustments.
- d) No overtime or holiday rate shall be payable by the County. If due to an emergency or Contractor scheduling, a guard must be paid overtime, this will be the responsibility of the Contractor.
- e) The County will compensate for overtime pay only when caused by special request of the County or by Force Majeure.
- f) Notwithstanding the hourly rates above, compensation shall be based upon the actual number of service hours performed, less any deductions/fines imposed for non-performance or other contract violations.
- g) The Equipment monthly rates shall include all costs of operating and maintaining all equipment throughout the term including, but not limited to, the cost of fuel, tire changes, insurance and cleaning. No “add-on” charges for services shall be accepted.

- h) Equipment shall be new at the inception of the contract
