Dear Chairman Rodriguez:

I am writing to request consideration for a Governor's appointment to the Governing Board of The Children's Trust. Attached you will find my resume, along our most recent annual report brochure.

Ever since I was a child myself, I knew I wanted to do something meaningful with my life. This aspiration led me to work with children in impoverished countries throughout the world. I soon became aware of the extent of the need in my community and country. Learning about the challenges so many face so close to my home, I began to get involved on a local level. It is a privilege to work for our women and children daily. I am so fortunate to witness firsthand how someone can transform their lives once they are given access to resources and are given the chance to heal. There is still so much work to be done and together we can continue to make meaningful change and save lives.

I have served as the Executive Director of Lotus House Women's Shelter since January of 2023 and in this capacity oversee daily operations of the Lotus Village facility, the largest women's homeless shelter in the country. Every day, 525+ women, youth and children experiencing homelessness are assisted at Lotus House – and over 1,450 annually.

My responsibilities as Executive Director include:

- Overseeing and management of the daily operations of both the Lotus Village, and our new project The Children's Village at Lotus Village
- development and implementation the organization's strategic plan, including budget oversight, resource allocation, and fundraising strategies
- building and maintaining relationships with key stakeholders, including board members, donors, and collaborators.
- providing direct supervision to Director and Deputy Directors, leadership to the team of 130
- ensuring compliance with all legal and regulatory requirements, including funding contracts
- overseeing the development and implementation of programs and services that meet the needs of those we serve
- managing the organization's budget: forecasting, tracking expenses, and identifying areas for cost savings.

Prior to this, I served as Director of Lotus House for over two years and as Community Outreach Coordinator and Programming Deputy Director for almost 6 years.

During my tenure as Executive Director of Lotus House much has been accomplished, with the following highlights:

- * 89% of our guests successfully exited outside of the shelter system in 2025

- * Lotus House expanded our services to reach the community in ***The Children's Village at Lotus Village***. The Children's Village at Lotus Village, a new, model, neighborhood children's resource center, brings together 14+ non-profits collectively serving an estimated 2,000-2,500 children from Lotus House and the Overtown community annually to provide deep educational and therapeutic support, enriched programming in the arts and science, a barrier free access point for health care and legal services, social services, and a child-centered platform for shared community. This collective impact model serves as a model for neighborhood programs for children living with housing instability and those at high risk for homelessness. Located right across the street from Lotus House, we opened the facility in October 2025. I currently serve on the Board of the Miami-Dade Homeless Trust (since May 2023), the National Women's Shelter Network (since Dec. 2023), the Miami-Dade's Homeless Trust Continuum of Care (CoC) Sub-Committee and Child Welfare and Juvenile Services Committee.

As Executive Director of Lotus House I continually work to develop and strengthen community collaborations that benefit the women, youth and children at Lotus House, including but not limited to: Miami Dade Public Schools System Project Upstart, Urgent Inc., Career Source of South Florida, Miami Dade College, Miami Dade Public Libraries, United Way of Miami Head Start – and the agencies that will be co-located in the Children's Village (Arts for Learning/Miami, Inc., Care4U, Easter Seals South Florida, Children's Bereavement Center, Inc., Alliance for LGBTQ Youth, Girl Power Rocks, Inc., Legal Services of Greater Miami, Mindful Kids Miami, Inc., Nana's Restart, Overtown Children and Youth Coalition, Overtown Optimist Club, Inc., Urgent, Inc.)

To advocate for women and children experiencing homelessness I frequently speak at local government Commission meetings, plan and direct Lotus House videos to increase public awareness of the surrounding issues and appear on Univision, Telemundo, Miami Herald, and MegaTV, and other media.

Having worked with Lotus House for more than 10 years, I believe I have much to offer as a member of the Governing Board of The Children's Trust. I bring a unique perspective and understanding of the most disenfranchised and trauma-affected in our community: women, youth and children who experience poverty, violence and homelessness – and their path to healing and transformation. My dedication to caring for this most disadvantaged group of children in our community has led me to seek service on the Board, to ensure their needs and interests are represented.
