Subject: FY 2024-2025 Community Based Organization (CBO) Report Card

Executive Summary

This report is provided pursuant to Implementing Order (IO) 3-15, Uniform Minimum Standards for Application, Contracting, Assessment, Monitoring, Organizational Review, and Performance Review of Community-Based Organizations (CBO). IO 3-15 requires that an annual Report Card detailing findings from CBO performance reviews monitored by the Office of Management and Budget (OMB) be presented to the Board on an annual basis.

In addition, this Report Card served as a key performance component of the analysis conducted in response to Resolution No. R-1174-25. That report evaluated the legacy CBOs included in the attached CBO Report Card to identify their geographic reach, scope of services, potential duplication of services, service effectiveness and performance metrics, financial dependency on County funds, and any overlap among CBO staff and CBO Board members. As part of that analysis, the report card ratings contained in this CBO Report Card were used to evaluate overall organizational performance.

Background

Miami-Dade County (County) provides CBO funding for services in twelve priority areas including: Anti-Violence; Basic Needs; Children & Adults with Disabilities; Children, Youth & Families; Criminal Justice; Elder Needs; Food Programs; Health; Immigrants/New Entrants; Special Needs; Workforce Development; and Other.

In accordance with IO 3-15, OMB conducted Performance Reviews to evaluate: 1) deliverables and program achievement, and 2) administration and contract compliance, which serve as the basis for the report card ratings.

The CBO Report Card rates organizations using a green, yellow, and red stoplight scale as follows:

- **Green** – five (5) or fewer instances of non-compliance
- **Yellow** – more than five (5) instances of non-compliance and/or receiving a suspension that has since been resolved
- **Red** – any number of instances of non-compliance that merit contract or payment suspension that are not resolved

FY 2024-2025 CBO Report Card

Attachment 1 is the FY 2024-25 CBO Report Card, inclusive of the rating for each organization. The report card also serves as a key performance component of the broader analysis conducted pursuant to Resolution No. R-1174-25, which reviewed legacy CBOs to understand their geographic reach, scope of services, service effectiveness, financial dependency on County funds, and potential duplication of services, staff, and CBO Board members. The findings of that analysis demonstrated that legacy CBOs collectively provide services across all Commission Districts and multiple funding categories, with limited duplication among Board members.

The following is a summary of the CBO Report Card findings:

- A total of 125 unique CBOs received General Fund contracts during FY 2024–2025. This includes 136 General Fund agreements executed, reflecting that 10 legacy CBOs also received

- one-time contracts separate from their standard CBO agreements, including one CBO who received multiple one-time contracts, which were monitored independently.
- A total of 114 agreements received a green rating, representing 104 unique CBOs.
 - 19 organizations received a yellow rating; of these, 13 were previously rated red and were upgraded to yellow upon acceptance of a Corrective Action Plan.
 - Three organizations received a red rating. One agency's contract was cancelled due to noncompliance, while two agencies received a red rating because their corrective action plans had not been approved as of the date of this report. CBOs receiving these ratings are paired with OMB-GC's capacity building section to help address factors affecting their service delivery. OMB-GC anticipates that one of the remaining corrective actions may be completed, allowing the organization to achieve compliance and resolve their red ratings. The other organization subsequently declined funding for FY 25-26.

Recognizing that many of these organizations are small agencies, OMB-GC maintains close communication and provides support in navigating their contracts through an assigned Contracts Officer, supplemented by a Capacity Building team that works directly with agencies to navigate government contracts and requirements. This includes providing opportunities to resolve outstanding issues and ensuring that both our focus and theirs remain on delivering valuable services to the residents of Miami-Dade County.
