Subject: Resolution Approving the Plat of Lions Trail Subdivision Filed by Lion Miami Terrace, LLC

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Lions Trail Subdivision is bounded on the north by SW 8 Street, on the east by SW 69 Avenue, on the south by SW 12 Street, and on the west by SW 70 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 6, which is represented by Commissioner Natalie Milian Orbis.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this plat; all improvements are in place.

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

- Proposed Usage: 230 apartments.
- Number of Parcels: One.
- This plat meets concurrency.
- These apartments and retail were determined to be within feasible distance to public water and public sanitary sewer using the feasible distance requirements in effect prior to the new feasible distance Ordinance No. 22-137. As a condition of this approval, the proposed development is required to connect to public water and public sanitary sewer services.

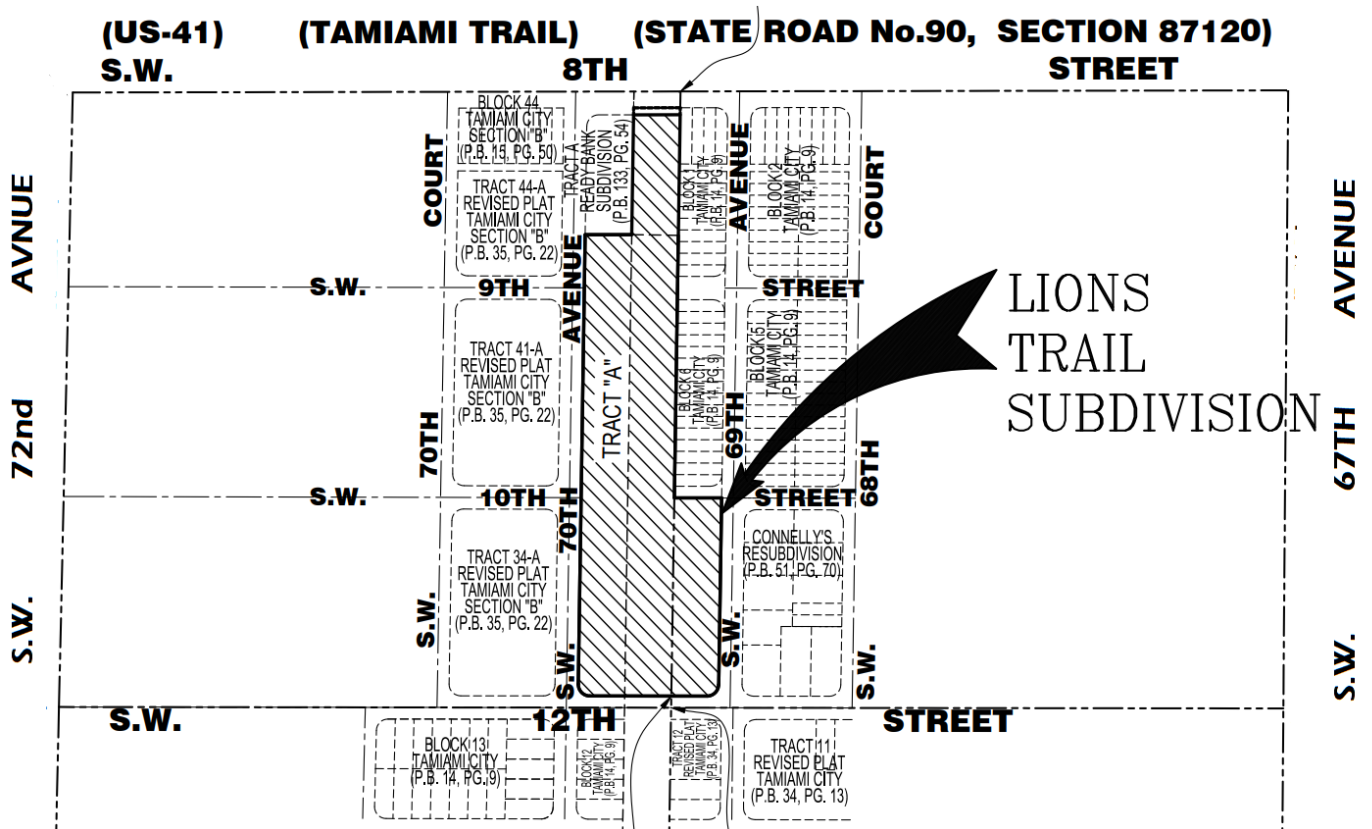

RESOLUTION APPROVING THE PLAT OF LIONS TRAIL SUBDIVISION, FILED BY LION MIAMI TERRACE, LLC, LOCATED IN THE NORTHEAST 1/4 OF SECTION 11, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 8 STREET, ON THE EAST BY SW 69 AVENUE, ON THE SOUTH BY SW 12 STREET, AND ON THE WEST BY SW 70 AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Lion Miami Terrace, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as “Lions Trail Subdivision,” the same being a replat of Tracts 7-A and 7-B, of “Revised Plat of Tamiami City,” according to the plat thereof, as recorded in Plat Book 34, at Page 13; Lots 1, 2, and 6, in Block 7, of “Tamiami City,” according to the plat thereof, as recorded in Plat Book 14, Page 9; Tracts 33-A, and 42-A of “Revised Plat of Tamiami City, Sec. “B”, according to the plat thereof, as recorded in Plat Book 35, Page 22, all of the Public Records of Miami-Dade County, Florida; the South 25 feet and a portion of S.W. 10th Street, closed by Resolution R-735-72; that portion of S.W. 9th and 10th Streets closed by Resolution 1287-84; and a subdivision of a portion of land lying and being in the Northeast 1/4, of Section 11, Township 54 South, Range 40 East, Miami-Dade County, Florida,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.

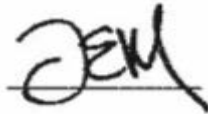
