WHEREAS, Resolutions No. R-238-21 and R-243-23 provide limitations on the use of allocations from the Arena Naming Rights Fund,

Program; and (3) waives the requirements of Resolutions No. R-238-21 and R-243-23 as related to the Arena Naming Fund allocations in accordance with the attached memorandums incorporated herein by reference.
