SUBJECT: Resolution Approving, Pursuant to Section 125.35(1)(b)(1), Florida Statutes, Development Lease Agreement ("Agreement") between the County, as Landlord and KASE LLC ("KASE") as Tenant and Developer, of County-Owned Land at Miami Executive Airport ("TMB") for a Term of 30 Years, with one Five-Year Renewal Option Contingent on Certain Conditions To Expand its Existing Premises from 435,884 Square Feet to 645,088 Square Feet and Demolish Buildings 232, 233, 234 and 235 To Accommodate the Development of Aviation Hangar Facilities, a Fixed-Based Operator Terminal, Fuel Farm Facilities and Ancillary Infrastructure, for an Estimated \$17,612,737.00 in Rents and other Revenues to the County over the Initial 30-Year Term, Inclusive of a Separate Payment of \$624,124.00 Associated with Two Leases that Form Part of the Existing Premises, Subject to Satisfaction of Conditions Precedent; Directing the County Mayor or County Mayor's Designee To Seek Approval from the Traffic and Consulting Engineers and from the Federal Aviation Administration of the Agreement; Authorizing the County Mayor or County Mayor's Designee To Execute the Lease, To Take All Actions Necessary To Execute same, and To Exercise All Rights Conferred Therein, Including the Termination Rights; Waiving the Requirements of Implementing Order 8-4 for Commission Auditor Review; and Directing the County Mayor or County Mayor's Designee To Provide an Executed Copy of the Lease to the County Property Appraiser's Office in Accordance with Resolution No. R-791-14

Pursuant to [Resolution No. R-129-22](#), adopted on February 1, 2022, and the new requirements per Implementing Order (I.O.) 8-4, the Office of the Commission Auditor (OCA) is directed to independently and simultaneously review and comment on the proposed leasing and conveyance of County property prior to the submission of an agenda item to the Board of County Commissioners (BCC). The OCA is providing this report as a Supplement to the BCC Agenda File Item No. 261518.

Commission Auditor's Observations:

The OCA conducted a comprehensive review of KASE, LLC, the intended party to the lease agreement. This review extended to the entity's key personnel. The results yielded the following:

- A. Background research performed on KASE, LLC, principals, and key personnel of the entity yielded no material observations or significant adverse findings.

Scope of Review:

The OCA's review of the subject lease agreement is based on information provided by the Aviation Department (MDAD), including the documents listed in the *Source Documents* section below.

As part of OCA's due diligence procedures, OCA identifies all entities and persons having a disclosed or observed interest in the BCC approval of the lease agreement (see Exhibit 1).

Methodology:

The OCA's review of the entity listed included the following procedures:

- A. A review of Board-approved conveyances to external parties for Infill, Affordable, and Workforce Housing as authorized through BCC resolution.
- B. A review of privately owned properties developed under the Miami-Dade County Infill Housing Program.
- C. A review of Miami-Dade County Property Appraiser, Clerk of the Courts, and Commission Legislation records to ascertain any evidence of risk factors, including entities with a history of previously conveyed or leased County-owned property that was later the subject of an involuntary reverter or lease termination by the County.
- D. A review of the Miami-Dade County Debarred Contractors list to ascertain any evidence of risk factors.
- E. Background research into corporate records, business affiliations, and registrations.
