RESOLUTION NO. _____ R-544-15

RESOLUTION RENAMING “RICHMOND TRIANGLE PARK” AS THE “RICHMOND HEIGHTS LEGACY PARK”; RENAMING “BEN SHAVIS PARK” AS THE “BEN SHAVIS LEGACY PARK”; RENAMING “LINCOLN ESTATES PARK” AS THE “LINCOLN ESTATES LEGACY PARK”; RENAMING “NARANJA LAKES PARK” AS THE “NARANJA LAKES LEGACY PARK”; DIRECTING THE COUNTY MAYOR OR DESIGNEE TO TAKE ALL STEPS NECESSARY TO EFFECTUATE SUCH NAME CHANGES

WHEREAS, “Richmond Triangle Park” is a Miami-Dade County park located at 14375 Boggs Drive in Richmond Heights, and is managed by the Parks, Recreation and Open Spaces Department (the “Parks Department”); and

WHEREAS, “Ben Shavis Park” is a Miami-Dade County park located at 17821 Southwest 104th Avenue in West Perrine, and is managed by the Parks Department; and

WHEREAS, “Lincoln Estates Park” is a Miami-Dade County park located at 22210 Southwest 108th Avenue in Goulds, and is managed by the Parks Department; and

WHEREAS, “Naranja Lakes Park” is a Miami-Dade County park located at 14410 Southwest 272 Street in Homestead, and is managed by the Parks Department; and

WHEREAS, each of these parks—“Richmond Triangle Park,” “Ben Shavis Park,” “Lincoln Estates Park,” and “Naranja Lakes Park”—are of special importance to the communities they serve, and represent a gift of public recreation space from the County’s present generations to the County’s future generations—a “legacy” of public parkland; and

WHEREAS, this Board desires to reflect the “legacy” nature of these parks by renaming them as the “Richmond Heights Legacy Park,” “Ben Shavis Legacy Park,” “Lincoln Estates Legacy Park,” and “Naranja Lakes Legacy Park”; and

WHEREAS, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding the proposed naming, renaming, or codesignation of Miami-Dade County roads, facilities or property shall be sponsored by the district commissioner where the road, facility, or property is located; and

WHEREAS, "Richmond Triangle Park," "Ben Shavis Park," "Lincoln Estates Park," and "Naranja Lakes Park" are located in County Commission District 9, represented by Commissioner Dennis C. Moss,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, renames "Richmond Triangle Park" as "Richmond Heights Legacy Park"; "Ben Shavis Park" as "Ben Shavis Legacy Park"; "Lincoln Estates Park" as "Lincoln Estates Legacy Park"; and "Naranja Lakes Park" as "Naranja Lakes Legacy Park."

Section 2. Directs the County Mayor or designee to revise all references to the parks identified in Section 1 and take all steps necessary to reflect the renamings, including through the installation of suitable signage.

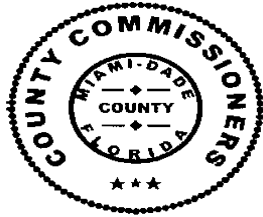
