Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 85 feet south of SW 32 Lane, on the east approximately 225 feet west of SW 148 Avenue, on the south by SW 34 Street, and on the west approximately 225 feet east of SW 149 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval and recording of this plat.

Scope

This plat is located in Commission District 11, which is represented by Commissioner Juan C. Zapata.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County, per the PWWM Department, would be approximately \$200.00 per year for the annual maintenance cost of that portion of SW 33 Terrace after the road is constructed adjacent to the project, which will be funded through PWWM General Fund allocation.

Track Record/Monitor

The Development Services Division of RER administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

• That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.

 That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.

 That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.

• That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

 Mobilization, clearing, paving, sidewalks, curb and gutter, valley gutter, drainage, traffic control signs, guardrail and monumentation. Bonded under bond number 7922 in the amount of \$71,119.00.
