RESOLUTION NO.	R-608-15

RESOLUTION DIRECTING THE MAYOR OR MAYOR'S DESIGNEE TO PROVIDE A REPORT IDENTIFYING THE NUMBER OF MULTI-AXLE VEHICLES AND TRAILERS REGISTERED IN MIAMI-DADE COUNTY, THE IMPACT ON TRAFFIC PATTERNS AND COUNTY ROAD SURFACES CAUSED BY SUCH VEHICLES, AND THE AMOUNT OF TAXES PAID, IF ANY, BY REGISTERED MULTI-AXLE VEHICLE OWNERS

WHEREAS, a multi-axle vehicle is a vehicle with more than the standard two-axles found in most passenger cars; and

WHEREAS, no study has been commissioned to investigate the impact on Miami-Dade County ("County") roads that multi-axle vehicles cause; and

WHEREAS, heavier vehicles produce more wear and tear on road surfaces, which necessitates thicker road pavements and more frequent repairs; and

WHEREAS, this Board believes it is in the County's best interest to investigate the cumulative impact of multi-axle vehicles traveling in the County in order to promote efficiencies for both travelers and future development of County roads,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the Mayor or Mayor's designee to provide to the Board a report identifying: (1) the number of multi-axle vehicles and trailers registered in Miami-Dade County; (2) the impact on traffic patterns and County road surfaces caused by such vehicles, including information regarding the wear and tear to roads that these heavier vehicles cause; (3) the amount of taxes paid, if any, by registered multi-axle vehicle owners. The Mayor or Mayor's designee shall provide the report to this Board
