Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for 1836, LLC, and Jorge Levy and Sandra Levy is bounded on the north by NE 211 Lane, on the east approximately 100 feet west of NE 18 Place, on the south approximately 90 feet north of NE 211 Terrace, and on the west by I-95 Expressway.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Legal description of the boundaries of the land are on file with the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 4, which is represented by Commissioner Sally A. Heyman.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

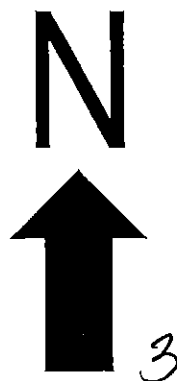
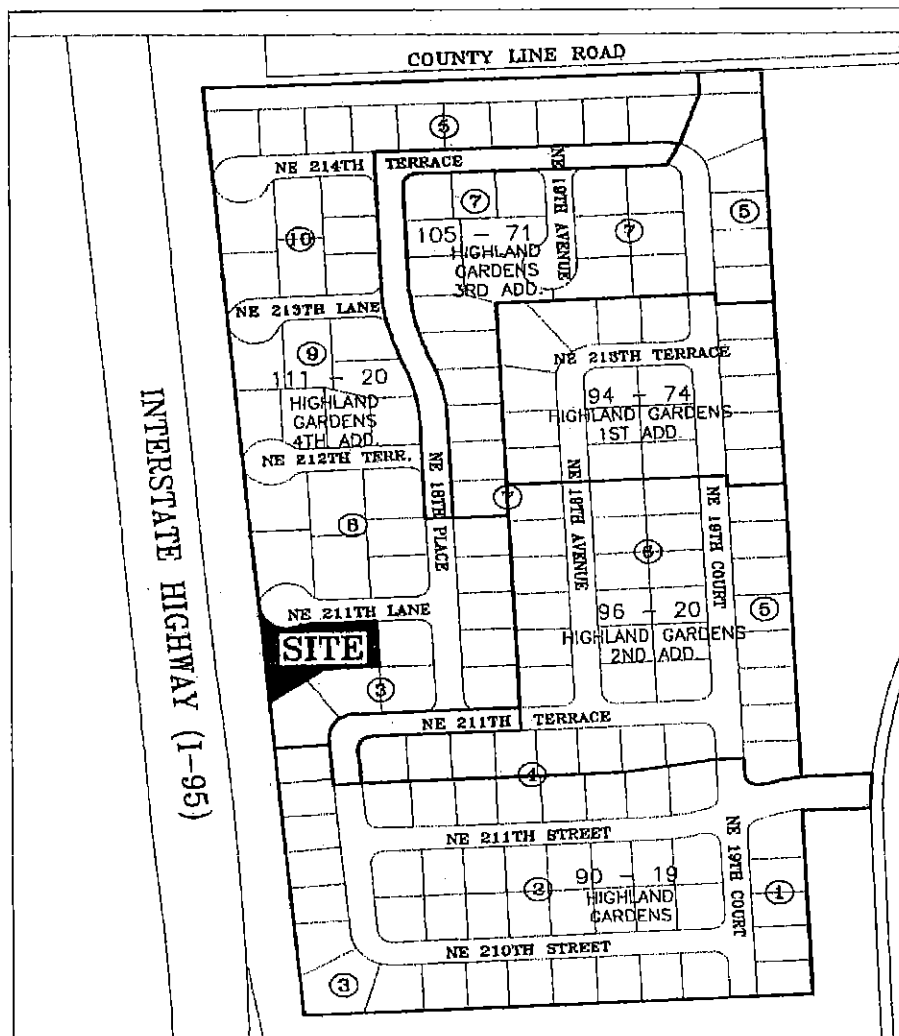

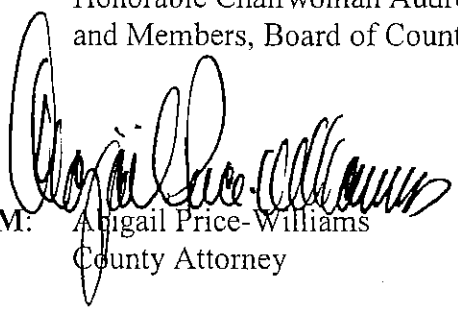

RESOLUTION APPROVING THE WAIVER OF PLAT OF 1836, LLC, AND JORGE LEVY AND SANDRA LEVY, D-24325, LOCATED IN THE NORTHWEST 1/4 OF SECTION 33, TOWNSHIP 51 SOUTH, RANGE 42 EAST (BOUNDED ON THE NORTH BY NE 211 LANE, ON THE EAST APPROXIMATELY 100 FEET WEST OF NE 18 PLACE, ON THE SOUTH APPROXIMATELY 90 FEET NORTH OF NE 211 TERRACE, AND ON THE WEST BY I-95 EXPRESSWAY)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

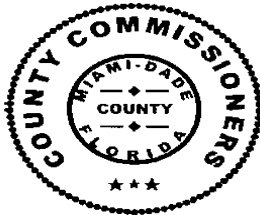
WHEREAS, 1836, LLC, and Jorge Levy and Sandra Levy, husband and wife, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as Lots 20 and 21, Block 3 of "Fourth Addition to Highland Gardens", according to the plat thereof, as recorded in Plat Book 111, at Page 20, of the Public Records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 33, Township 51 South, Range 42 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28, Subdivisions, of the Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.
