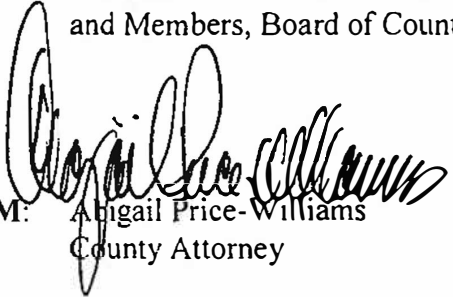

RESOLUTION NO. R-310-20

RESOLUTION WAIVING, BY A TWO-THIRDS VOTE OF THE FULL MEMBERSHIP OF THE BOARD, THE RESIDENT AND ELECTOR REQUIREMENTS OF SECTION 2-11.38 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA FOR MIAMI-DADE COUNTY ASIAN AMERICAN ADVISORY BOARD MEMBER VIVEK "VICTOR" SWAROOP; AND REAPPOINTING VIVEK "VICTOR" SWAROOP TO THE MIAMI-DADE COUNTY ASIAN AMERICAN ADVISORY BOARD

WHEREAS, on July 22, 1997, the Miami-Dade County Board of County Commissioners (the "Board") adopted Ordinance No. 97-128, establishing the Miami-Dade County Asian-American Advisory Board ("Asian-American Advisory Board"), which is codified in article LXXIX of chapter 2 the Code of Miami-Dade County, Florida (the "Code"); and

WHEREAS, the Asian-American Advisory Board presents and advises the Board on matters of interest to the Asian community; and

WHEREAS, pursuant to section 2-1087 of the Code, the Asian-American Advisory Board consists of 26 members, all of whom are appointed by this Board; and

WHEREAS, sections 2-1087 and 2-11.38 of the Code, respectively, require that members of the Asian-American Advisory Board and all members of County boards be permanent residents and electors of Miami-Dade County; and

WHEREAS, Vivek "Victor" Swaroop was first appointed to serve on the Asian-American Advisory Board on February 20, 2013 and has served as a dutiful member of the board since that time; and

WHEREAS, during his tenure on the Asian-American Advisory Board, Mr. Swaroop:

- 1) served as a co-chair of the Asian American Advisory Board's 20th Anniversary Community Recognition Dinner;
- 2) was integral in the organization and presentation of the International Day of Yoga Celebration at the Stephen P. Clark Center;
- 3) organized Gandhi Peace Day in Miami; and
- 4) is actively involved with the Asian-American Advisory Board's education/civic engagement and cultural advancement committees; and

WHEREAS, Mr. Swaroop is a resident of Broward County, Florida; and

WHEREAS, a copy of Mr. Swaroop's resume is attached hereto as Exhibit A; and

WHEREAS, pursuant to section 2-11.38 of the Code, the Board is authorized by a two-thirds vote of its membership to waive this residency requirement; and

WHEREAS, this Board desires to waive the resident and elector requirements of section 2-11.38 and reappoint Mr. Swaroop to serve on the Asian-American Advisory Board,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Ratifies and adopts the matters set forth in the foregoing recitals.

Section 2. By a two-thirds vote of its full membership, pursuant to section 2-11.38 of the Code of Miami-Dade County, waives the residency and elector requirements of the Code for Miami-Dade County Asian-American Advisory Board member Vivek "Victor" Swaroop.

Section 3. Reappoints Vivek "Victor" Swaroop to the Miami-Dade County Asian-American Advisory Board.

The Prime Sponsor of the foregoing resolution is Commissioner Barbara J. Jordan. It was offered by Commissioner **Barbara J. Jordan**, who moved its adoption. The motion was seconded by Commissioner **José "Pepe" Diaz** and upon being put to a vote, the vote was as follows:

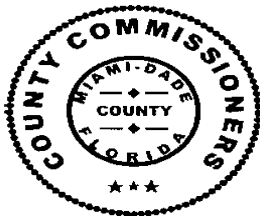
