



Subject: Resolution Approving a Maintenance Map for a Portion of SW 168 Street
between SW 97 Avenue and South Dade Transit Way

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the attached resolution approving a Maintenance Map for a portion of SW 168 Street between SW 97 Avenue and South Dade Transit Way, authorizing the Chairwoman and the Clerk of the Board to certify same, and authorizing the recordation thereof in the Public Records of Miami-Dade County, Florida.

Scope

The subject road is located within District 9, represented by County Commissioner Dennis Moss.

Fiscal Impact/Funding Source

There is currently no increase in maintenance costs to the County as a result of this action.

Track Record/Monitor

The Department of Transportation and Public Work (DTPW) is the entity overseeing this project and the person responsible for monitoring it is Mr. Leandro Oña, P.E., Chief, Roadway Engineering and Right-of-Way Division.

Background

The subject road has been maintained continuously by DTPW for over four years. In accordance with Section 95.361, Florida Statutes, title to a road maintained by the County for over four years vests in the County. The filing of a Maintenance Map in the Office of the Clerk of the Court, which has been certified by the Chairwoman and the Clerk of the Board, is deemed prima facie evidence of ownership by the County. The subject Maintenance Map has been executed by the Assistant Director of Construction and Maintenance of the DTPW, certifying that the County has maintained this road for over four years. It is recommended the Maintenance Map, provided as Attachment 1 to the Resolution, be approved by the Board after which it will be certified by the Chairwoman and the Clerk of the Board and recorded in the Public Records of Miami-Dade County, Florida. An affidavit from the Assistant Director of Construction and Maintenance, describing the County's maintenance is attached as Attachment 2.

RESOLUTION NO. _____ R-402-20

RESOLUTION APPROVING A MAINTENANCE MAP FOR A PORTION OF SW 168 STREET BETWEEN SW 97 AVENUE AND SOUTH DADE TRANSIT WAY, IN SECTIONS 28 AND 33 TOWNSHIP 55 SOUTH RANGE 40 EAST, AUTHORIZING THE CHAIRWOMAN AND THE CLERK OF THE BOARD TO CERTIFY THE MAINTENANCE MAP, AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE SAME AND AUTHORIZING THE RECORDING THEREOF AMONG THE PUBLIC RECORDS OF MIAMI-DADE COUNTY FLORIDA

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, the Director of Department of Transportation and Public Works has recommended that an Official Maintenance Map be filed of record to indicate prima facie evidence of ownership, pursuant to the provisions of Section 95.361 of the Florida Statutes and the County Mayor has concurred in such recommendation,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board ratifies and adopts these matters set forth in the foregoing recitals.

Section 2. This Board approves the Maintenance Map for a portion of SW 168 Street between SW 97 Avenue and South Dade Transit Way in Sections 28 and 33, Township 55 South Range 40 East, attached as Attachment 1, authorizes the Chairwoman and the Clerk of the Board to certify same pursuant to Section 95.361 of the Florida Statutes, and authorizes the County Mayor or Mayor's designee to take all actions necessary to effectuate same.

A

Section 3. Pursuant to Resolution No. R-974-09, this Board (a) directs the County Mayor or County Mayor's designee to record any instruments executed in connection herewith which create or reserve a property interest in favor of the County, in the Public Records of Miami-Dade County, Florida; and to provide a recorded copy of instruments to the Clerk of the Board within thirty (30) days of execution of said instruments; and (b) directs the Clerk of the Board to attach and permanently store a recorded copy of said instruments together with this resolution.

The foregoing resolution was offered by Commissioner **Audrey M. Edmonson** who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:


