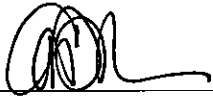

National Haitian American Elected Officials Network, Inc. (Community Event)	\$ 1,695.00,

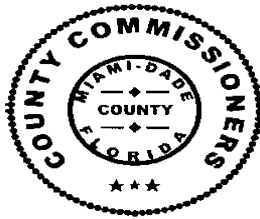
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
