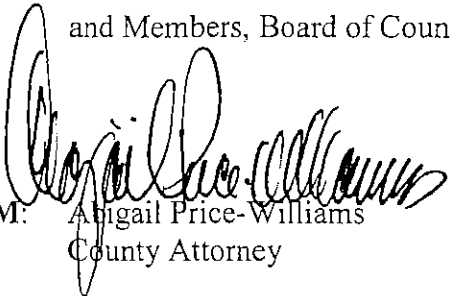

RESOLUTION RENAMING THE REVEREND DR. EDWARD T.
GRAHAM NEIGHBORHOOD CENTER LOCATED AT 16405
N.W. 25TH AVENUE, AS THE "REVEREND DR. EDWARD T.
GRAHAM COMMUNITY RESOURCE CENTER"

WHEREAS, in honor of the significant contributions Reverend Dr. Edward T. Graham made to Miami-Dade County through his activism and advocacy for racial equality and social justice, on November 19, 2019, this Board adopted Resolution No. R-1199-19, which renamed the Miami Gardens Neighborhood Service Center located at 16405 N.W. 25th Avenue, Miami Gardens as the Reverend Dr. Edward T. Graham Neighborhood Center; and

WHEREAS, the center should have been renamed as the "Reverend Dr. Edward T. Graham Community Resource Center"; and

WHEREAS, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding proposed naming, renaming, or codesignation of Miami-Dade County roads, facilities, or property shall be sponsored by the district commissioner where the road, facility or property is located; and

WHEREAS, the Reverend Dr. Edward T. Graham Neighborhood Center is located in County Commission District 1; and

WHEREAS, this Board wishes to rename the Reverend Dr. Edward T. Graham Neighborhood Center,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Incorporates and adopts the foregoing recitals herein by reference.

Section 2. Having considered this matter at a public hearing, renames Reverend Dr. Edward T. Graham Neighborhood Center, located at 16405 N.W. 25th Avenue, Miami Gardens, as the “Reverend Dr. Edward T. Graham Community Resource Center”.

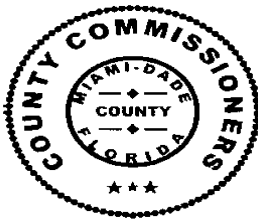
Section 3. Directs the County Mayor or County Mayor’s designee to revise any references to the Reverend Dr. Edward T. Graham Neighborhood Center, to the “Reverend Dr. Edward T. Graham Community Resource Center” and to install appropriate signage to reflect the name.

Section 4. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Mayor of Miami Gardens, the Miami Gardens City Council, the Miami Gardens City Manager, the Miami Gardens Police Department, the United States Postal Service, the Traffic Signals and Signs Division of the Transportation and Public Works Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade County Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Barbara J. Jordan. It was offered by Commissioner **Barbara J. Jordan** , who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
