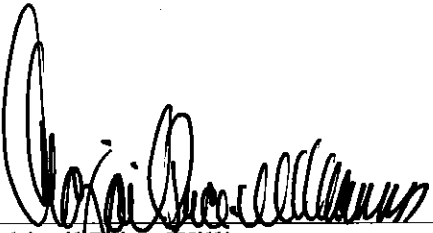

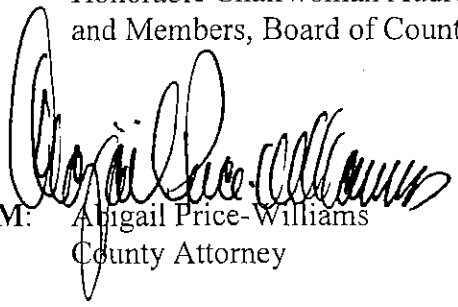

RESOLUTION NO. R-222-20

RESOLUTION URGING THE FLORIDA LEGISLATURE TO
ENACT SB 906, HB 1415, OR SIMILAR LEGISLATION THAT
WOULD PROHIBIT GREEN IGUANAS AND BLACK AND
WHITE TEGUS FROM BEING KEPT, POSSESSED,
IMPORTED INTO THIS STATE, SOLD, BARTERED, TRADED,
OR BRED IN THIS STATE

WHEREAS, pursuant to article IV, section 9 of the Florida Constitution, the Florida Fish and Wildlife Conservation Commission ("FWC") exercises the regulatory and executive powers of the state with respect to wild animal life, fresh water aquatic life, and marine life, including the power to control and manage nonnative species; and

WHEREAS, nonnative species are animals living outside captivity and which are not historically present in the state; and

WHEREAS, more than 500 fish and wildlife nonnative species have been documented in Florida; and

WHEREAS, not all nonnative species pose a threat to Florida's ecology, but some nonnative species become invasive species by causing harm to native species, posing a threat to human health and safety, or causing economic damage; and

WHEREAS, to manage and minimize the impacts of nonnative species, it is unlawful to import for sale or use, or to release within the state, any species not native to Florida unless authorized by the FWC; and

WHEREAS, the black and white tegu (*Salvator merianae*), commonly referred to as a tegu, is a large species of lizard that can grow up to four feet in length and is native to South America; and

WHEREAS, tegus are an invasive species and have known breeding populations in Miami-Dade and Hillsborough counties and an emerging population in Charlotte County; and

WHEREAS, the tegu causes harm to native species by disturbing alligator nests and consuming their eggs, and utilizing gopher tortoise burrows and consuming juvenile gopher tortoises; and

WHEREAS, green iguanas (*Iguana iguana*) are large, typically green lizards, though they can sometimes be brown or almost black in color, that can grow to over five feet in length and weigh up to 17 pounds; and

WHEREAS, green iguanas are a nonnative, invasive species that can live on the ground, in shrubs, or in trees in a variety of habitats including suburban developments, urban areas, small towns, and agricultural areas, and particularly thrive in South Florida's warm, humid climate; and

WHEREAS, green iguanas cause damage to residential and commercial landscape vegetation and are often considered a nuisance by property owners; and

WHEREAS, some green iguanas cause damage to infrastructure by digging burrows that erode and collapse sidewalks, foundations, seawalls, berms, and canal banks; and

WHEREAS, to address the threat to Florida's ecology posed by these nonnative species, a pair of identical bills—Senate Bill (SB) 906 and House Bill (HB) 1415—has been filed for consideration during the Florida Legislature's 2020 session by Senator Gary Farmer, Jr. (D – Fort Lauderdale) and Representative Dan Daley (D – Sunrise), respectively; and

WHEREAS, SB 906 and HB 1415 would add the green iguana and the black and white tegu to the list of species that may not be kept, possessed, imported into the state, sold, bartered, traded, or bred in this state; and

WHEREAS, this Board has previously urged the Florida Legislature to ban the sale of black and white tegus, as evidenced by Resolution Nos. R-147-16 and R-850-16; and

WHEREAS, accordingly, this Board would like to express its support for SB 906, HB 1415, or similar legislation,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature to enact SB 906, HB 1415, or similar legislation that would add the green iguana (*Iguana iguana*) and the black and white tegu (*Salvator merianae*) to the list of species that may not be kept, possessed, imported into the state, sold, bartered, traded, or bred in this state.

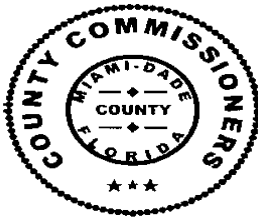
Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, Senate President, Senator Gary Farmer, Jr., Representative Dan Daley, and House Speaker, the Chair and Members of the Miami-Dade State Legislative Delegation, and the Executive Director of the Florida Fish and Wildlife Conservation Commission.

Section 3. Directs the County's state lobbyists to advocate for the legislation set forth in section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2020 State Legislative Package to include this item.

The Prime Sponsor of the foregoing resolution is Vice Chairwoman Rebeca Sosa. It was offered by Commissioner **Audrey M. Edmonson** , who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
