RESOLUTION AUTHORIZING MIAMI-DADE COUNTY TO JOIN THE ANTI-DEFAMATION LEAGUE'S FLORIDA HATE CRIME COALITION (FHCC); DIRECTING THE COUNTY MAYOR OR THE COUNTY MAYOR'S DESIGNEE TO TAKE ALL NECESSARY STEPS TO JOIN THE FHCC

WHEREAS, the Anti-Defamation League (ADL) leads the Florida Hate Crime Coalition (FHCC), which is a coalition of well over 200 members, including law enforcement leaders, elected officials, civil rights groups, and other non-profit organizations; and —

WHEREAS, the ADL is an anti-hate organization, founded in 1913, which opposes anti-Semitism and extremism, and whose stated mission is to secure justice and fair treatment to all; and

WHEREAS, the FHCC was established in 2016 with a mission to make Florida's hate crime law comprehensive by expressly providing for the inclusion of bias crimes committed because of physical disability, gender, or gender identity, as well as "association with" or "mixed motive" hate crimes, in Florida's hate crime law; and

WHEREAS, hate crime statistics from the Federal Bureau of Investigation indicate that hate crimes in Florida have remained at record highs in 2017 and 2018; and

WHEREAS, the FHCC supports comprehensive hate crime laws as a way to "recognize that these crimes strike special fear within victimized groups, fragment communities, and tear at the very fabric of our democratic way of life"; and

WHEREAS, this Board believes that diversity in our community is a source of strength and opportunity, and is committed to promoting tolerance, inclusion, and public safety; and

WHEREAS, this Board condemns acts of hatred and intolerance, and supports the efforts of the FHCC to expand Florida's hate crime law; and

WHEREAS, this Board wishes to memorialize its support for the FHCC and its mission by becoming a member of the FHCC,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the foregoing recitals, which are incorporated as if fully set forth herein.

Section 2. Authorizes Miami-Dade County to join the Anti-Defamation League's Florida Hate Crime Coalition (FHCC).

<u>Section 3.</u> Directs the County Mayor or County Mayor's designee to take any and all necessary steps to ensure that Miami-Dade County becomes a member of the FHCC.
