Request for Additional Expenditure Authority to Prequalification Pool No. RTQ-

00837, Purchase, Maintenance, and Repair of Physical Fitness Equipment

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize additional expenditure to *Prequalification Pool No. RTQ-00837, Purchase, Maintenance, and Repair of Physical Fitness Equipment*, for the Fire Rescue and Parks, Recreation and Open Spaces Departments. These departments are requesting additional expenditure authority in the amount of \$600,000 to continue to purchase, repair, and maintain physical fitness equipment. The Mayor established this pool under delegated authority on August 8, 2018 for a four-year term. This prequalification pool incudes two groups: Group 1 – Equipment; and Group 2 – Repair and Maintenance Services.

The additional expenditure authority will be used as follows:

- 1. Due to an inspection performed of Fire Rescue's physical fitness equipment in 2019, the department requires an allocation increase of \$300,000 to purchase new equipment to replace outdated or inoperable equipment. Much of the equipment has been in place for over 20 years and in many cases repair parts are no longer available or repair costs far exceed the current value and/or the cost of replacement. Furthermore, there are three new fire stations (18, 29, and 68) scheduled for completion during the term of this pool, and will require new exercise equipment prior to inauguration. Fire Rescue is committed to ensuring all first responders stay physically active and maintain a healthy physical condition for the rigorous activities required in the field. One way to ensure personnel stay healthy is by providing functional physical fitness equipment.
- 2. Parks, Recreation and Open Spaces requires an allocation increase of \$300,000 to purchase new physical fitness equipment, upgrade and replace outdated equipment, and repair and maintain old equipment that is breaking down. The allocation will also be utilized towards creating a preventative maintenance program to prolong the life of new and aging equipment identified by the department during the term of the pool. The fitness center at North Pointe Community Center was managed by the YMCA and is now being managed by Parks, Recreation and Open Spaces. As a result, the department needs to repair and/or replace damaged or outdated equipment. The department did not anticipate having to manage this site. In addition, new community centers with fitness centers and physical fitness programs have been opened which require new equipment and subsequent maintenance and repair. The additional community centers include Father Gerard Jean-Juste Community Center at Oak Grove Park, Arcola Lakes Senior Center, Goulds Park and Gwen Cherry Park. The fitness centers offer a variety of classes to the community via monthly membership.

Scope.

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The pool term expires on August 31, 2022. The pool has a current cumulative allocation of \$870,000. If this request is approved, the pool will have a modified cumulative allocation of \$1,470,000.
