Resolution Retroactively Authorizing the County Mayor to Apply for Grant Funds in the Amount of \$22,360,552.00 from the United States Department of Transportation, Federal Transit Administration, Fiscal Year 2019, BUILD Transportation Grants Program and Authorizing the Mayor to Receive and Expend said Grant Funds for The Underline Project

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the attached resolution retroactively authorizing the County Mayor or County Mayor's designee to apply for grant funds in the amount of \$22,360,552.00 from the United States Department of Transportation (USDOT), Federal Transit Administration (FTA), Fiscal Year (FY) 2019 "Better Utilizing Investments to Leverage Development" (BUILD) Transportation grants program. The funding will be used for the design and construction of the remaining portion of the Underline Multi-Use Trail/Mobility Corridor (The Underline) transportation component from SW 19th Avenue to the Dadeland South Metrorail Station. It is further recommended that the Board authorize the receipt and expenditure of funds, as specified in the Agreement.

A public hearing is required in accordance with federal regulations.

Scope.

The project is in Commission District 5 and Commission District 7, represented by Commissioner Eileen Higgins and Commissioner Xavier L. Suarez, respectively.

Fiscal Impact/Funding Source

The estimated cost for the Underline transportation component is \$69,941,592.00. The approved BUILD grant funding for this project is \$22,360,552.00. The remaining project costs of \$47,581,040.00 will be provided using FY 2019 State appropriation funding through the Florida Department of Transportation, Miami-Dade County Road Impact Fees and private funding. The Federal share of project costs for which an expenditure is made under the BUILD grant program may not exceed 80 percent.

The FY 2019-2020 Adopted Budget and Multi-Year Capital Plan includes The Underline project, which has already received more than \$16 million of local County funding, \$14 million of State funding through DTPW and \$6.6 million from the City of Miami. Funding from the City of Coral Gables and additional City of Miami and State funding have also been identified. The Department of Transportation and Public Works (DTPW) plans to again include this project and funding in the FY 2020-2021 Proposed Budget and Multi-Year Capital Plan.

Track Record/Monitor

Grant Manager for this Agreement is Ed Carson, Manager, Grants Administration, DTPW. The project will be monitored by Irene Hegedus, Chief, DTPW, Transportation Enhancements Division.

Background

The Underline is a 10-mile multimodal mobility corridor starting from the Miami River (Downtown) to the Dadeland South Metrorail station that repurposes underutilized parking and green space beneath the existing Metrorail. The Underline project transverses three municipalities (City of Miami, City of Coral Gables and City of South Miami) as well as portions of unincorporated Miami-Dade County. The project provides for the design and construction of separated bike and walking facilities, improvement of 36 intersection crossings, lighting, wayfinding and access to eight Metrorail stations and bus terminals allowing for increased ridership and safety.

Construction of The Underline began in December of 2018 (Brickell Backyard – 0.5 miles). The design/build criteria package for an additional portion of the project (Hammock – 2.14 miles) was finalized in July 2018 and DTPW is currently in the procurement phase with design and construction expected to start in March 2020 and completed in December 2023. The design/build criteria package for the rest of the project from SW 19th Avenue to the Dadeland South Metrorail Station is already in the procurement phase, which is expected to be completed by September 2020. Once the design/build criteria package is finalized, procurement of the rest of the project will take place as funding is identified. DTPW anticipates the design and construction of the project to be completed December 2025.

On April 23, 2019, USDOT announced the availability of \$900 million for the National Infrastructure Investments Under the Consolidated Appropriations Act, 2019. This appropriation stems from the programs funded and implemented pursuant to the American Recovery and Reinvestment Act of 2009 and is known as the BUILD Transportation grants program. For this round of BUILD Transportation grants, the maximum award is \$25 million. Funds for the FY 2019 BUILD grant are awarded on a competitive basis for surface transportation infrastructure projects that will have a significant local or regional impact.

On July 12, 2019, DTPW submitted a project application requesting \$22,360,552.00 in BUILD grant funding for the remaining portions of the Underline's transportation component. The grant advance notice was published on USDOT's website on November 6, 2019. DTPW was selected to receive an award of \$22,360,552.00 for The Underline project. However, to receive the funding, DTPW is required to submit a completed paper grant application to USDOT, which is pending receipt and a subsequent electronic grant application to FTA in substantially the form attached.

DTPW anticipates completion of the design and construction of the project by December 2025.
