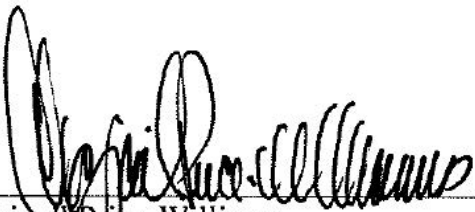

Subject: Resolution Requesting the Florida Department of Transportation (FDOT) to Convey, at No Cost, Properties Located on the East and West Sides of the Limited Access Right-of-Way of State Road 93 (I -75)

Recommendation

It is recommended that the Board of County Commissioners approve the attached resolution requesting rights-of-way conveyances from the Florida Department of Transportation (FDOT) to be used for road and canal public purposes and authorize the Chairperson of the Board of County Commissioners to accept said conveyances on behalf of Miami-Dade County.

Scope

The portion of these parcels located on the West side of the I-75 are within District 12, represented by Commissioner Jose "Pepe" Diaz, and the portion located on the East side of the I-75 are within District 13, represented by Commissioner Esteban Bovo, Jr.

Fiscal impact/funding Source

There is a fiscal impact associated with these subject parcels being included in the Miami-Dade County Roads System. The assumption of the right-of-way will increase the maintenance costs by approximately \$1,280 annually due to the addition of 2500 linear feet of two-lane road. These costs will be funded through the General Fund and the Stormwater Utility fund.

Track Record/Monitor

The Department of Transportation and Public Works (DTPW) is the entity overseeing this project and the person responsible for monitoring is Alejandro Barrios, Manager, Stormwater Engineering and Right-of-Way Division.

Background

As part of the I-75 project and pursuant to Resolution No. R-1463-79, a canal right-of-way for the Golden Glades Canal was conveyed to FDOT by Quit Claim Deed dated December 13, 1979, recorded in Official Records Book 10620, Page 577, of the Miami-Dade County Public Records. The deed conveying the canal rights-of-way included a restriction that the rights-of-way be used for highways purposes only and if the rights-of-way were no longer used by the State for highway purposes, the deed stated that "said rights-of-way shall terminated in and to such portion abandoned and no longer used as aforesaid." On January 10, 2008, FDOT and the County concluded the exchange of property rights authorized by a special agreement approved by Resolution No. R-17-08, which granted an easement for highway purposes by the County to the

FDOT as per Quit Claim Deed dated October 18, 2007, recorded in Official Records Book 26262, Page 174. Pursuant to Section 334.044(17) Florida Statutes, the FDOT, by action of the District Secretary, District Six, authorized the relocation of the limited access right-of-way lines as per FDOT Right-of-Way map for State Road No. 93 in Section 87075 FP 250696-6-32-02, dated April 5, 2019, recorded in Plat Book 154 at Page 19 of the Public Records of Miami-Dade County as depicted in Exhibit 3. FDOT, by virtue of the relocation of the limited access right-of-way lines, has abandoned and will no longer use the properties identified as Parcels 101-RA, 101-RB, 100-A2C, 100-B2N, 100-B2S, 102B, 102-BC, 122, 100-A1C, 100-B1N, and 100-B1S. Pursuant to Section 337.25(4)(b) Florida Statutes, properties to be used for a public purpose may be conveyed without consideration to a governmental entity upon approval by the Secretary of the Department of Transportation. In furtherance of the completion of these exchanges, the FDOT, by action of the District Six Secretary, has agreed to convey, by quitclaim deeds, the lands herein described, without consideration, to Miami-Dade County.

The County wishes to facilitate the opening of the existing NW 170 Street Bridge over I-75. This opening will improve access and mobility, alleviate traffic congestion and accommodate future growth and development in the area. As mentioned above, to assist this effort, FDOT has agreed to transfer land abutting State Road 93 (I-75) to the County. In March 2019, as the first step in the process, FDOT relocated the Limited Access Right-of-Way to exclude the parcels that they no longer need for State Highway purposes, making them available for transfer to Miami-Dade County. Per this resolution, the County is requesting rights-of-way conveyances from FDOT of the aforementioned parcels. These parcels will be used for road and canal public purposes.

The parcels, to be conveyed by quit claim deeds, are legally described in Exhibits "1" and "2" and depicted on Exhibit "3" to this Memorandum.

WHEREAS, the Department and the County cooperated with each other in connection with the Department's construction of the transportation facility known as State Road 93 (''I-75''); and

WHEREAS, said land is no longer required for state highway purposes, the Department, by action of the District Secretary, District Six, has agreed to re-convey, by quitclaim deed, the lands herein described to the County, without consideration, as an Administrative Transfer, done in accordance with the provisions of Section 337.25, Florida Statutes.

RESOLUTION REQUESTING THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO CONVEY AT NO COST PROPERTIES LOCATED ON THE EAST AND WEST SIDES OF THE LIMITED ACCESS RIGHT-OF-WAY OF STATE ROAD 93 (I -75), ALSO KNOWN AS PARCELS 101-RA, 101-RB, 100-A2C, 100-B2N, 100-B2S, 102B, 102-BC, 122, 100-A1C, 100-B1N, AND 100-B1S, IN SECTIONS 9 AND 16, TOWNSHIP 52 SOUTH, RANGE 40 EAST, MIAMI-DADE COUNTY, FLORIDA, BY QUIT CLAIM DEEDS TO MIAMI-DADE COUNTY FOR PUBLIC PURPOSES; DELEGATING AUTHORITY TO THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE SAME; AND AUTHORIZING THE CHAIRPERSON OF THE BOARD OF COUNTY COMMISSIONERS TO ACCEPT SAID CONVEYANCES

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Miami-Dade County has requested the Florida Department of Transportation (FDOT) to convey, at no cost, properties acquired by eminent domain for state highway purposes including the portion of NW 170 Street between theoretical NW 95 Avenue and NW 89 Avenue as set forth in the Quit Claim Deeds attached as Exhibit "1" and Exhibit "2" to the Mayor's Memorandum and depicted in Exhibit "3" to the Mayor's Memorandum,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The recitals and findings of this Resolution are adopted and incorporated herein.

Section 2. This Board approves Quit Claim Deed “1”, in substantially the form attached to the Mayor’s Memorandum as Exhibit “1”, conveying to the County the following Parcels 101-RA, 101-RB, 102B, 102BC, and 122 in Section 9-52-40, as said parcels are legally described and depicted in Exhibits “A” and “B” of said Quit Claim Deed attached to the Mayor’s Memorandum and authorizes the Chairperson of the Board of County Commissioners to accept such conveyances on behalf of the County.

Section 3. This Board approves Quit Claim Deed “2”, in substantially the form attached to the Mayor’s Memorandum as Exhibit “2”, conveying to the County the following Parcels 100A1C, 100A2C, 100B1N, 100B1S, 100B2N, and 100B2S in Section 16-52-40 which are legally described and depicted in Exhibits “A” and “B” of said Quit Claim Deed attached to the Mayor’s Memorandum and authorizes the Chairperson of the Board of County Commissioners to accept such conveyances on behalf of the County.

Section 4. This Board delegates the authority to the County Mayor or County Mayor’s designee to take all actions necessary to effectuate the transfer of parcels in Quit Claim Deed “1” and Quit Claim Deed “2.” Pursuant to Resolution No. R-974-09, this Board (a) directs the County Mayor or County Mayor’s designee to record any instruments executed in connection herewith which create or reserve a property interest in favor of the County, in the Public Records of Miami-Dade County, Florida, and to provide a recorded copy of instruments to the Clerk of the Board within thirty days of execution of said instruments; and (b) directs the Clerk of the Board to attach and permanently store a recorded copy of said instruments together with this resolution.

The foregoing resolution was offered by Commissioner **Rebeca Sosa** , who moved its adoption. The motion was seconded by Commissioner **Daniella Levine Cava** and upon being put to a vote, the vote was as follows:

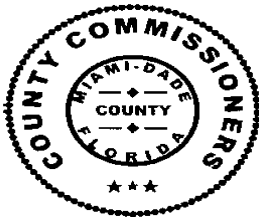
