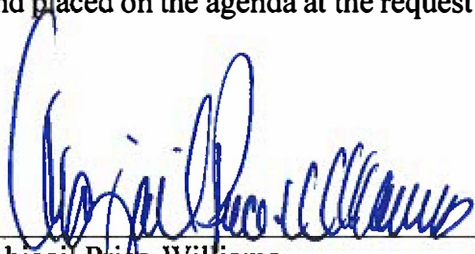

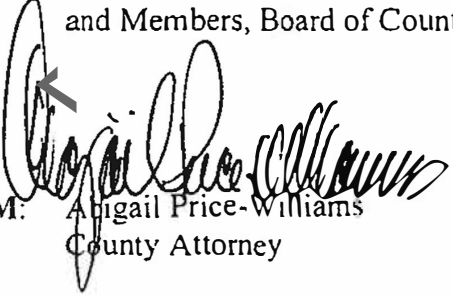

RESOLUTION NO. R-318-20

RESOLUTION URGING THE FLORIDA LEGISLATURE TO
APPROVE MEDICAID EXPANSION FOR CERTAIN
QUALIFIED ADULTS UNDER THE AGE OF 65 IN AN EFFORT
TO ADDRESS THE PUBLIC HEALTH EMERGENCY CAUSED
BY CORONAVIRUS DISEASE 2019 (COVID-19)

WHEREAS, in December 2019, a new coronavirus, known as SARS-CoV-2, that causes an infectious disease named coronavirus disease 2019 (“COVID-19”) was first identified in Wuhan, Hubei Province, China; and

WHEREAS, on January 30, 2020, the International Health Regulations Emergency Committee of the World Health Organization (“WHO”) declared the outbreak a “public health emergency of international concern”; and

WHEREAS, since its initial identification, COVID-19 has spread rapidly across the world and cases of COVID-19, as well as mortalities from it, are increasing by the day; and

WHEREAS, on March 1, 2020, Governor Ron DeSantis issued Executive Order No. 20-51 in response to COVID-19, directing the State Health Officer and Surgeon General to declare a public health emergency in the state of Florida and directing the State Health Officer to take any action necessary to protect the public health and to follow guidelines established by the Center for Disease Control and Prevention (“CDC”) to control the spread of COVID-19; and

WHEREAS, on March 9, 2020, Governor DeSantis issued Executive Order No. 20-52, declaring a state of emergency in the state of Florida, designating the Director of the Division of Emergency Management as the State Coordinating Officer for the duration of the emergency, and delegating the State Coordinating Officer with the authority to exercise the powers delineated in §§ 252.36(5) – (10), Florida Statutes, as needed to meet the emergency; and

WHEREAS, on March 11, 2020, given the rapid spread and severity of the virus, the WHO declared COVID-19 a pandemic; and

WHEREAS, on March 12, 2020, Mayor Carlos A. Gimenez declared a local state of emergency for Miami-Dade County invoking his authority to issue orders to protect the health, safety, and welfare of the community, including possibly imposing a curfew and closing certain businesses; and

WHEREAS, on a daily basis, the Florida Department of Health is reporting increases in confirmed cases of Florida residents with COVID-19 and in deaths from COVID-19 in Florida; and

WHEREAS, in an effort to reduce the possibility of mass exposure in Florida, Walt Disney World and Universal Studios announced closures from March 16, 2020 through the end of the month, schools and universities have temporarily closed in favor of remote learning options, and numerous other large social and community events and gatherings have been cancelled as precautionary measures to protect the community; and

WHEREAS, similarly, on a national front, professional and college sports leagues, including, but not limited to, the National Basketball Association, Major League Baseball, National Collegiate Athletic Association, National Hockey League, and the Professional Golfers' Association have suspended operations; and

WHEREAS, businesses and government offices are continuing to announce new closures daily to ensure the protection of the public health, safety, and welfare as a result of COVID-19; and

WHEREAS, without access to health care coverage, many Floridians who may be infected with COVID-19 may be reluctant to seek treatment and could expose others to the deadly virus; and

WHEREAS, according to the report “Health Insurance Coverage in the United States: 2018,” issued by the United States Census Bureau (“Census Bureau”), 13 percent of Florida residents do not have health insurance, making Florida the fourth highest state in the nation for uninsured residents; and

WHEREAS, Florida’s uninsured rate exceeds the national average of 8.5 percent by more than 50 percent; and

WHEREAS, the report also provides that the number of uninsured residents in Florida increased from approximately 2.68 million in 2017 to roughly 2.73 million in 2018; and

WHEREAS, uninsured Floridians account for nearly 10 percent of the reported 27.5 million Americans who did not have health insurance in 2018; and

WHEREAS, Medicaid is a joint federal and state program that provides health coverage for some low-income people, families, and children, pregnant women, the elderly, and people with disabilities; and

WHEREAS, the 111th United States Congress passed the Patient Protection and Affordable Care Act of 2010 (“Affordable Care Act”) and on March 23, 2010, the President signed the bill into law; and

WHEREAS, one of the key components of the Affordable Care Act required states to expand Medicaid to a minimum national eligibility threshold of 139 percent of the federal poverty level effective January 1, 2014; and

WHEREAS, the United States Supreme Court did not uphold this provision, which essentially gave states the option to expand Medicaid; and

WHEREAS, although the Affordable Care Act authorizes Medicaid expansion, which in effect would provide health care coverage to a greater number of Floridians, to date the Florida Legislature has opted not to do so; and

WHEREAS, in fact, in 2013, 2014, 2015, 2019, and 2020, bills that would have authorized Medicaid expansion were filed for consideration by the Florida Legislature, but were not heard or did not pass; and

WHEREAS, according to the Census Bureau, Florida is one of only eight states in the nation that has not expanded Medicaid; and

WHEREAS, Medicaid expansion would provide more low-income Floridians with access to vital health care coverage at this critical time in history; and

WHEREAS, additionally, the Legislature may call a special session to address issues related to COVID-19, as well as the expected economic downturn, and resulting impacts on Floridians and corresponding reductions in state revenue; and

WHEREAS, such a special session would provide the Legislature with an opportunity to expand Medicaid and draw down significant federal funds, which would not only provide millions of Floridians with access to health care coverage, but also a funding boost for the economy; and

WHEREAS, in light of COVID-19 and for public health purposes, it is necessary that Floridians who are most in need have access to health insurance; and

WHEREAS, further, the benefits of expanded Medicaid eligibility would not only serve those who would obtain health care coverage, but the general public as well because the number of uninsured people would decrease and the number of people who receive health care treatment would likely result in a corresponding increase, which among other things, diminishes the likelihood of transmitting communicable diseases such as COVID-19; and

WHEREAS, in consideration of the public health emergency caused by COVID-19 and the pressing need many Floridians have for health care coverage, this Board urges the Florida Legislature to expand Medicaid eligibility,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature to approve Medicaid expansion for all adults under the age of 65 with incomes equal to or below 138 percent of the federal poverty level in an effort to address the public health emergency caused by coronavirus disease 2019 (COVID-19).

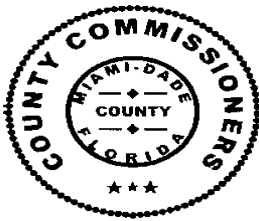
Section 2. Directs the Clerk of the Board to transmit certified copies of this resolution to the Governor, Senate President, House Speaker, the Chair and Members of the Miami-Dade County State Legislative Delegation, and the Secretary of the Florida Agency for Health Care Administration.

Section 3. Directs the County's state lobbyists to advocate for the action set forth in section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2020 State Legislative Package to include this item and to include this item in the 2021 State Legislative Package when it is presented to the Board.

The Prime Sponsor of the foregoing resolution is Chairwoman Audrey M. Edmonson. It was offered by Commissioner **Audrey M. Edmonson** , who moved its adoption. The motion was seconded by Commissioner **Sally A. Heyman** and upon being put to a vote, the vote was as follows:
