Subject: Resolution Authorizing the County Mayor or County Mayor's Designee to Execute a Grant Application with the Federal Transit Administration in the amount of \$1,000,000 for Fiscal Year 2020 Section 5307 Grant Program Flexible Funding for Metrorail and Metromover Guideway Bridge Inspections

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the terms of, and authorize the County Mayor or County Mayor's designee to execute a grant application on behalf of the County with the United States Department of Transportation, Federal Transit Administration (FTA) in the amount of \$1,000,000 for Fiscal Year (FY) 2020, Section 5307 grant program flexible funding for the Metrorail and Metromover Guideway Bridge Inspections project. It is further recommended that the Board authorize the receipt and expenditure of funds, as specified in the Agreement.

A public hearing is required in accordance with federal regulations.

Scope

This funding will provide support for inspecting structural elements of the Metrorail and Metromover guideways. Therefore, the impact is countywide.

Fiscal Impact/Funding Source

Once awarded, this Agreement provides a positive fiscal impact to the County as it awards funding to the Department of Transportation and Public Works (DTPW). Additionally, the required local match of \$250,000 will be provided in full by the Florida Department of Transportation (FDOT) through the use of State Transportation Development Credits as a "soft match" for this grant.

The Fixing America's Surface Transportation ACT (FAST Act) authorizes state transportation departments to make available to public transit agencies the use of transportation development credits on selected federally assisted public transit capital projects. By using these credits to substitute for the required non-federal share on a federal-aid project, the federal share can effectively be increased to 100 percent.

Track Record/Monitor

The Grant Manager for this Agreement is Ed Carson, Manager, Grants Administration, DTPW. German Arenes, P.E., Chief of Construction, Structural Inspections and Analysis, DTPW will monitor the guideway inspection work.

Background

Pursuant to Section 335.074, Florida Statutes, government entities are required to perform safety inspections of bridges they maintain for structural soundness and safety. To comply with state statute, DTPW initiated the Guideway Bridge Inspection Program in 1986. Every two years, DTPW inspects 25 miles of Metrorail and 4.4 miles of Metromover elevated guideway structures.

Through the Miami-Dade Transportation Planning Organization (TPO), the Federal Highway Administration (FHWA) provides flexible Surface Transportation Block Grant Program (STBG) funding for the Metrorail and Metromover guideway bridge inspections. The FAST Act allows STBG funding to be transferred to the FTA for public transportation projects that are eligible under the Section 5307 program. When such flexible fund transfers are made for eligible transit projects, FTA will administer these funds in a separate Section 5307 grant.

On December 19, 2019, the FHWA approved the transfer of \$1,000,000 in FY 2020 flexible funding to the FTA Section 5307 grants program for the Metrorail and Metromover Guideway Bridge Inspections project. This funding will be used for the inspections of structural elements of the Metrorail and Metromover guideways. Eligible activities include, third-party consultant, in-house guideway inspection services and comprehensive bridge inspection training classes approved by FDOT. Upon approval by the Board, DTPW will submit a grant application to the FTA in substantially the form attached.

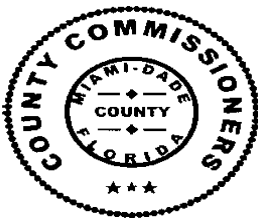
