	RESOLUTION URGING THE UNITED STATES CONGRESS			

TO INCLUDE DIRECT AND FLEXIBLE FUNDING TO COUNTIES IN FUTURE STIMULUS OR OTHER RELIEF PACKAGES TO ASSIST WITH THE ECONOMIC DOWNTURN CAUSED BY CORONAVIRUS DISEASE 2019 (COVID-19)

WHEREAS, in December 2019, a new coronavirus, known as SARS-CoV-2, that causes an infectious disease named coronavirus disease 2019 ("COVID-19") was first identified in Wuhan, Hubei Province, China; and

WHEREAS, on January 30, 2020, the International Health Regulations Emergency Committee of the World Health Organization ("WHO") declared the outbreak a "public health emergency of international concern"; and

**WHEREAS**, on March 11, 2020, given the alarming spread and severity of the virus, the WHO declared COVID-19 a pandemic; and

**WHEREAS**, the first case of COVID-19 in the United States was reported on January 20, 2020; and

WHEREAS, since its initial identification in the United States, daily reports from the United States Centers for Disease Control and Prevention reveal that the number of confirmed COVID-19 cases and related deaths continue to increase at an exponential rate; and

WHEREAS, the United States Congress recognized that the full resources of the federal government are necessary to protect the health and well-being of the nation and has appropriated funding to address the devastating impacts of COVID-19 in three separate relief packages; and

WHEREAS, although more than \$2 trillion dollars has been appropriated in response to COVID-19, more funding to support counties is desperately needed; and

WHEREAS, the majority of funding appropriated by Congress in response to the virus has been tied to medical needs or reimbursement of costs related to same, which are undoubtedly necessary; and

WHEREAS, however, COVID-19 has ravaged county budgets and has created or is causing funding voids beyond those directly related to public health and medical supplies; and

WHEREAS, although Congress has approved and the President has signed record legislation for funding appropriations to address the unprecedented crisis caused by COVID-19, much more will be required; and

WHEREAS, counties, irrespective size, are on the front lines of this public health calamity and have expended millions of dollars and will likely spend billions in response to COVID-19; and

WHEREAS, counties are reliant on sales tax revenues, such as those collected by the Florida Department of Revenue and tied to revenue sharing and discretionary sales surtaxes for infrastructure, public hospitals, and transportation services, which have plummeted due to "safer at home" and "shelter in place" orders that require residents to remain in their residences, subject to limited exceptions, in an effort to reduce the transmission of the virus; and

WHEREAS, similarly, the economies of states that are largely dependent on tourism have been wrecked by the decline in travel caused by COVID-19; and

WHEREAS, additionally, many state and federal governments have pushed back tax filing deadlines, which will trickle down and negatively impact the 2020-2021 fiscal year budgets for counties; and

WHEREAS, demands for county services have increased significantly and such demand will likely continue throughout the summer and could extend beyond the end of 2020; and

WHEREAS, the economic costs of COVID-19 is much greater than the surplus revenue held by many counties in anticipation of a bleak economy; and

WHEREAS, without additional federal assistance, counties, which are required to have balanced budgets, will be forced to cut services or raise taxes, both of which would further harm people, businesses, and the economy when they are the most vulnerable and the least equipped to withstand the injury; and

WHEREAS, in light of job losses and business closures, there will probably be record numbers of people throughout the nation relying on county services at a time when tax revenue to fund such services has been radically reduced; and

WHEREAS, for the foreseeable future, the fiscal outlook for counties throughout the nation is grim; and

WHEREAS, this Board urges Congress to provide additional funding to counties to fund services and support residents,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the United States Congress to include direct and flexible funding to counties in future stimulus or other relief packages to assist with the economic downturn caused by coronavirus disease 2019 (COVID-19).

Section 2. Directs the Clerk of the Board to transmit certified copies of this resolution to the members of the Florida Congressional Delegation, Secretary of the United States Department of Health and Human Services, Governor, Senate President, House Speaker, and Chair and Members of the Miami-Dade County State Legislative Delegation.

Section 3. Directs the County's federal lobbyists to advocate for the action set forth in section 1 above.

Section 4. Authorizes and directs the Office of Intergovernmental Affairs to amend the 2020 Federal Legislative Package to include this item and to include this item in the 2021 Federal Legislative Package.

The Prime Sponsor of the foregoing resolution is Chairwoman Audrey M. Edmonson. It was offered by Commissioner Audrey M. Edmonson , who moved its adoption. The motion was seconded by Commissioner Rebeca Sosa and upon being put to a vote, the vote was as follows:
