RESOLUTION NO. R-456-20

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO: (1) PARTNER WITH MIAMI-DADE STATE ATTORNEY **KATHERINE** FERNANDEZ RUNDLE ("STATE ATTORNEY") ON AN EXPEDITED OUTREACH CAMPAIGN TO SUPPORT VICTIMS OF DOMESTIC VIOLENCE DURING THE PERIOD OF "SAFER AT HOME" PROTOCOLS RELATING TO CORONAVIRUS DISEASE 2019 (COVID-19); (2) PARTNER WITH THE STATE ATTORNEY TO DEVELOP A SLOGAN, HASHTAG, TEXTING CAPABILITY, QUICK RESPONSE CODE, AND OTHER CREATIVE APPROACHES TO SUPPORT THE CAMPAIGN; (3) DESIGNATE A POINT PERSON WHO WILL WORK WITH THE STATE ATTORNEY TO IMPLEMENT THE CAMPAIGN; (4) EXPAND THE COUNTY'S DOMESTIC VIOLENCE HELPLINE; (5) IDENTIFY LEGALLY AVAILABLE FUNDING WITHIN THE CURRENT FISCAL YEAR TO IMPLEMENT THE CAMPAIGN AND EXPAND THE HELPLINE; AND (6) PROVIDE A REPORT

WHEREAS, in early 2020, the State of Florida, including Miami-Dade County, as well as other areas in the United States and in countries around the world, began experiencing an outbreak of the infectious disease known as coronavirus disease 2019 ("COVID-19"); and

WHEREAS, in response to COVID-19, Florida Governor Ron DeSantis issued Executive

Order Number 20-51, directing the State Health Officer and Surgeon General to declare a public

health emergency in the State of Florida and directing the State Health Officer take any action

necessary to protect the public health and to follow guidelines established by the United States

Center for Disease Control and Prevention ("CDC") to control the spread of COVID-19; and

WHEREAS, in response to the COVID-19 pandemic, public health officials and the CDC have encouraged communities experiencing an outbreak to limit face-to-face contact with others as much as possible, and have urged individuals to practice "social distancing" to combat the spread of the virus; and

WHEREAS, to enforce social distancing, state and local governments around the country have banned large gatherings of people and issued "shelter in place" orders requiring residents to remain in their residences, subject to limited exceptions; and

WHEREAS, on March 26, 2020, Mayor Carlos Gimenez issued Miami-Dade County Emergency Order Number 12-20, urging all residents and visitors to remain in their homes other than to engage in essential activities; and

WHEREAS, such order, combined with previous Miami-Dade County Emergency Orders related to the COVID-19 pandemic, are referred to as "Safer at Home" protocols; and

WHEREAS, on April 3, 2020, Governor Ron DeSantis issued Executive Order Number 20-91 ordering all persons in Florida to limit their movements and personal interactions outside of their home to only those necessary to obtain or provide essential services or conduct essential activities; and

WHEREAS, Safer at Home protocols are intended to limit the spread of COVID-19 and reduce serious illness and death from the disease; and

WHEREAS, while the Safer at Home protocols keep the community safe from the spread of this infectious disease, they have the potential to cause an increase in domestic violence disputes because people in abusive relationships or violent home situations may be unable or unwilling to leave their homes to avoid the abuse or violence; and

WHEREAS, Miami-Dade State Attorney Katherine Fernandez Rundle ("State Attorney") desires to partner with the County on an outreach campaign to support victims of domestic violence during the period of the Safer at Home protocols; and

WHEREAS, this Board desires to partner with the State Attorney in her efforts to support victims of domestic violence; and

WHEREAS, this Board also desires to expand access to the County's Coordinated Victims Assistance Center ("CVAC"), a coordinated access point for domestic violence services and shelter, by expanding the 24-hour helpline to include additional forms of communication,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Directs the County Mayor or County Mayor's designee to partner with Miami-Dade State Attorney Katherine Fernandez Rundle on an expedited outreach campaign to inform and provide easy access to protection, shelter, and services for victims of domestic abusive violence during the period of Safer at Home protocols. The goal of the campaign is to inform potential domestic violence victims that the County's shelters and community service providers are available and have taken steps to accommodate social distancing and other guidelines from the CDC to keep families together and safe from COVID-19. The campaign should direct victims to the County's domestic violence helpline at (305) 285-5900 ("Helpline"), which is operated 24 hours a day, seven days a week by CVAC, as well as to the State Attorney's Office informational number at (305) 547-0140, which is currently operated 24 hours a day, seven days a week. The campaign shall be designed to engage and communicate with potential victims of domestic violence in multiple media and in areas, both virtual and physical, where people are together during the COVID-19 pandemic.

Section 2. Directs the County Mayor or County Mayor's designee to partner with the State Attorney to develop (1) a hashtag, texting capability and Quick Response (QR) code, which is a type of barcode that a smartphone user can scan, for use on social media; (2) a slogan; and (3) creative approaches to rapidly and thoroughly spread this message. For example, signs could be placed where people wait in line outside essential businesses such as grocery stores and pharmacies, fliers could be placed in the bags of people purchasing items in person or being delivered, and the County's COVID-19 webpage could incorporate the campaign message. The multimedia communications developed for this campaign shall encourage victims to seek help in any form they can, including but not limited to text, phone, email, or going to a physical location.

Section 3. Directs the County Mayor to designate a point person who will work with the State Attorney to implement the campaign immediately.

Section 4. Directs the County Mayor or County Mayor's designee to expand the County's Helpline to include additional forms of communication, such as text, chat, hashtag and QR code.

Section 5. Directs the County Mayor or County Mayor's designee to identify legally available funding within the current fiscal year to implement the campaign and expansion of the Helpline.

Section 6. Directs the County Mayor or County Mayor's designee to provide a report to this Board within 60 days of the effective date of this resolution and place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65. The report shall describe the campaign; the methods, techniques, and slogans used; any information available to indicate the campaign's effectiveness, such as an increase in calls to the Helpline and the number of people

using the County's domestic violence shelters and services; and the fiscal impacts of the campaign and expansion of the Helpline or, alternatively, indicate why the campaign or expansion of the Helpline cannot be implemented.

The Prime Sponsor of the foregoing resolution is Vice Chairwoman Rebeca Sosa. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **José ''Pepe'' Diaz** and upon being put to a vote, the vote was as follows:
