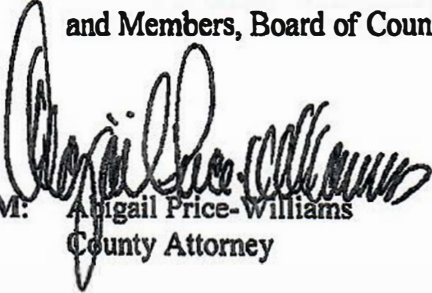

RESOLUTION DIRECTING THE COUNTY MAYOR OR
COUNTY MAYOR'S DESIGNEE TO SURVEY PASSENGERS
ABOUT THEIR EXPERIENCES WITH AIRLINES AT MIAMI
INTERNATIONAL AIRPORT AND PROVIDE A REPORT TO
THIS BOARD ABOUT THE IMPLEMENTATION AND RESULTS
OF SUCH SURVEYS

WHEREAS, the leading economic engine for Miami-Dade County, Miami International Airport ("MIA"), ranks among the busiest airports in the world and the third-busiest airport in the United States for international passengers; and

WHEREAS, MIA boasts a lineup of over 100 air carriers; and

WHEREAS, the Miami-Dade Aviation Department ("MDAD") strives to offer customers a world-class experience when traveling to and through MIA; and

WHEREAS, one way to achieve this objective is to survey passengers about their experience with the air carriers who service MIA; and

WHEREAS, this would allow MDAD the opportunity to share the results of such surveys with the airlines so that they are able to better understand their operations at MIA from the customers' perspective and in turn improve customer satisfaction; and

WHEREAS, passengers who share their positive encounters would also assist MIA's air carriers in understanding which methods yield the best results at MIA; and

WHEREAS, passengers who share their negative experiences would allow airlines to identify and focus on areas for improvement; and

WHEREAS, because passenger satisfaction at MIA is an essential part of the world-class experience, this Board believes that the County Mayor or County Mayor's designee should survey passengers about their experiences with airlines at MIA,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

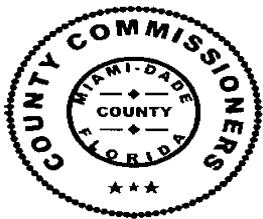
Section 1. Directs the County Mayor or County Mayor's designee to survey passengers about their experiences with airlines at Miami International Airport.

Section 2. Directs the County Mayor or County Mayor's designee to provide a report to this Board pursuant to Ordinance No. 14-65 within 60 days of the effective date of this resolution about the implementation and results of the surveys identified in section 1 above.

The Prime Sponsor of the foregoing resolution is Senator Javier D. Souto. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Daniella Levine Cava** and upon being put to a vote, the vote was as follows:
