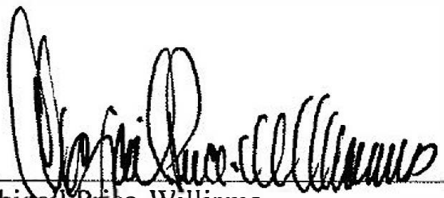

following allocations from the FY 2019-20 District 2 CBO Discretionary Reserve:

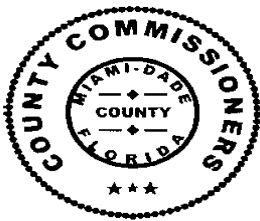
Divine Praise and Worship Ministries, Inc.
