

RESOLUTION NO. **R-453-20**

RESOLUTION DIRECTING COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO SEND, DURING DECLARED PUBLIC HEALTH STATES OF EMERGENCY THAT AFFECT ELECTIONS, EVERY HOUSEHOLD IN MIAMI-DADE COUNTY WITH AT LEAST ONE VOTER WHO DOES NOT HAVE A VOTE-BY-MAIL BALLOT REQUEST ON FILE A VOTE-BY-MAIL BALLOT REQUEST FORM ALONG WITH DIRECTIONS ON REQUESTING A VOTE-BY-MAIL BALLOT AND UPDATING THEIR VOTER'S SIGNATURE USING LEGALLY AVAILABLE FUNDING SOURCES

WHEREAS, voters in the State of Florida are eligible to vote by mail or in person either at an early voting location during the early voting period or at a polling place on election day; and

WHEREAS, voters using a vote-by-mail ballot may cast their votes from their own homes without the need to wait in line or travel to an early voting location or polling place during an election; and

WHEREAS, each vote-by-mail ballot cast is one less voter that will appear at an early voting location or polling place thus reducing the total volume of voters at those locations; and

WHEREAS, section 101.62, Florida Statutes, only authorizes Supervisors of Elections to send vote-by-mail ballots to voters upon their request; and

WHEREAS, during declared public health states of emergency that affect elections, it is safer for voters to remain at home and exercise their right to vote by using vote-by-mail-ballots; and

WHEREAS, encouraging voters to vote by mail by providing every household with at least one voter who does not have a vote-by-mail request on file directions on requesting a vote-by-mail ballot will encourage voters to vote by mail and provide much needed relief at early voting locations and polling places; and

WHEREAS, sending every household with at least one voter who does not have a vote-by-mail request on file detailed instructions on the importance and process for updating the voter's signature on file with elections will allow voters to update their current signature so that canvassing of their vote-by-mail ballot is easier and more efficient; and, and

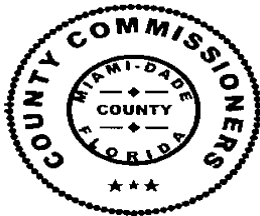
WHEREAS, this Board believes that in times of declared public health states of emergency that affect elections, sending every household with at least one voter who does not have a vote-by-mail request on file detailed instructions on how to request a vote-by-mail ballot and the importance and process for updating the voter's signature on file with elections will allow Miami-Dade County voters to maximize citizen participation in the electoral process and provide a safe and orderly procedure for persons seeking to exercise their right to vote,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor or County Mayor's designee, during declared public health states of emergency that affect elections, to use legally available funding sources to send every household with at least one voter who does not have a vote-by-mail ballot request on file a vote-by-mail ballot request form for each registered voter in the household without a vote-by-mail ballot request on file along with instructions on how to request a vote-by-mail ballot and the importance and process for updating the voters signature on file with elections to encourage the expanded use of vote-by-mail balloting in elections during such states of emergency.

The Prime Sponsor of the foregoing resolution is Chairwoman Audrey M. Edmonson, and the Co-Sponsors are Commissioner Daniella Levine Cava, Commissioner Jose "Pepe" Diaz, Commissioner Sally A. Heyman and Commissioner Dennis C. Moss. It was offered by Commissioner **Daniella Levine Cava**, who moved its adoption. The motion was seconded by Commissioner **Barbara J. Jordan** and upon being put to a vote, the vote was as follows:
