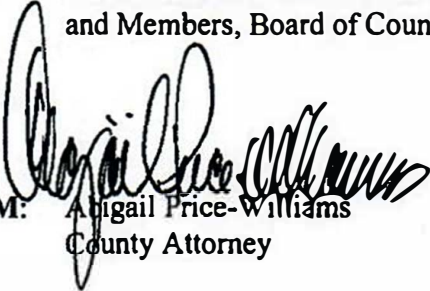

(Black Advisory Trust Fund for 2020 Pillar Awards Program) \$500.00,

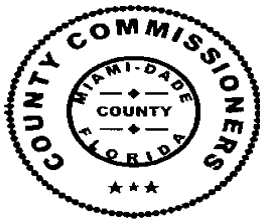
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
