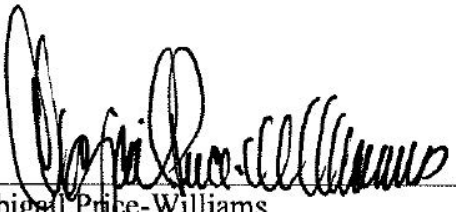

The Miami Foundation, Inc. (Avenue 3 Fund)	\$ 5,000.00,

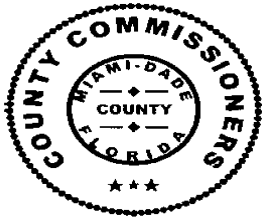
